Kansas Secretary of State, Kris W. Kobach, was the guest speaker at the Prairie Land Electric Cooperative annual meeting of the members on Tuesday.

Kobach spoke to the members concerning HB 2067 known as the Secure and Fair Elections Act. The bill calls for evidence of U.S. citizenship when a Kansan registers to vote, proof of identity at the time of voting, stronger penalties for voter crimes and increases resources for investigating and prosecuting election fraud.

In an interview following the meeting, bill and his reasons for supporting HB

"The bill will free up the state's county attorneys as the investigation and prosecution of voter fraud will handled by the State Attorney General." said Kobach. "There are over 221 possible fraud cases in Kansas that have not been fully investigated concerning voter fraud. County Attorney's just do not have the time and resources.'

"KWCH out of Wichita did a poll in which 78 percent of the persons polled approved the idea of providing "id" when voting,' said Kobach.

Mr. Kobach said that this concerns new registers and citizens over age 65 who can use an expired identification card, "We are not going to make our elders go out and get new identification cards."

"We will be able to compare driver's license rolls with voter rolls and catch any discrepancies. So far this year, we have seen 13 cases that need to be investigated," said Kobach.





School gets a break from fire marshal

s.haynes@nwkansas.com An agreement between the state fire marshal and legislators means Kansas school districts won't have to replace classroom doors and make other repairs designed to keep smoke from a hallway out of classrooms for up to an hour – at least not right away

The work should never have been ordered because state law exempts older buildings from having to meet updated fire codes, said Acting Fire Marshal Doug

been sent to about 54 Kansas schools in more than 30 districts, he said.

State Rep. Ward Cassidy of St. Francis, who had introduced a bill to exempt school districts from the repairs until the state school budget comes back to normal, said the reversal by the marshal's office is fine, but he wants to see the law changed to protect schools and businesses from this kind of inspection.

"We're in the process of reworking it to try to protect (schools) in the future," said
