School gets bids for bus

A regular route bus and the spare, or "back up bus," have recently had mechanical problems. As a result of these mechanical problems and the lack of another, suitable, spare bus, Superintendent Greg Mann contacted used bus dealers "in the area" on Monday morning to see what was available for purchase and then sent out requests for bids on Monday afternoon to three dealers of used buses; American Bus Sales, Master's Transportation and National Bus Sales.

The bid specifications sent out called for a 47 passenger diesel powered bus with an automatic transmission and fewer than 30,000 miles.

A special meeting of the USD 211 Board of Education was called for noon on Tuesday, to present the board with the results of the bids.

County told 'burn ban' is not legal

Norton County commissioners looked at a burn ban for the county after several "controlled" fires got out of hand.

During their meeting last Monday, the commissioners discussed passing a resolution similar to one written up for Graham County, which has also had problems with controlled burns getting out of control.

The commissioners were concerned because several fires, which had been set to burn off pastures and such, have gotten out of hand and the rural fire departments have had to be called in to get maximum.

them put out.

Last week, commissioners said, firemen were called out at 1:30 p.m. to fight a grass fire that got out of control. Some of the men didn't get home until 9:30 p.m.

Commissioner John Miller said there have been three or four similar instances in the last three to four weeks and the firemen are getting tired of it.

However, the resolution from Graham County is unconstitutional, Norton County Attorney Doug Sebelius told the commissioners.

The biggest problem with it, he said, is that while it sets a minimum penalty for fires that get out of control there is no

The state fire marshal's rules, he said, permits crop and pasture management.

This basically means, the state and county can't have a blanket no-burn policv, except in cases of extreme conditions such has high winds or very dry periods.

The person doing the burning doesn't even have to ask permission, Sebelius said. The prevailing norm is notification. In Norton County that usually means notifying the sheriff's office, which is also the dispatch, which notifies the rural fire departments.

The fires must be constantly supervised, of course, he said, and this is only
