Commission talks merging courts

The Kansas Supreme Court's Blue Ribbon Commission held a town meeting Monday at Prairie Land Electric. The job of the commission is to examine our court system and to make recommendations to the Supreme Court on how to better serve the citizens of Kansas.

Two meetings were held, one for community leaders and one for the public. The meeting was held by three commission members, Donna Elliott, clerk of the court in Graham County, Richard Flax, District Magistrate Judge out of Trego County in WaKeeney and Kim Cudney, the Chief Judge from the 12th Judicial District from Washington County.

The commission's job is to collect information, suggestions and ideas from community leaders and private citizens and take it back to the Supreme Court. They are looking for things the courts can do regionally or from a central location to improve efficiency. How the courts can put technology to use. How to be more flexible with manpower and facilities as

workloads fluctuate and any other ideas people may have.

These meetings will take place across the State of Kansas until June at which time the commission will reconvene to come up with suggestions for the court. In December the commission will take their recommendations to the Supreme Court and then in January or February the Supreme Court will take the final plan to the legislature.

Those in attendance were asked for their input and ideas. Karen Glenn, Deputy Clerk of Norton County, voiced her concerns with regionalizing the court

"When the judge is gone and we must fax the information to another judge we will be dealing with time issues and confusion. Each judge handles things differently," said Glenn.

Curt Archibald, Solid Waste Supervisor at the Norton County Landfill, said, 'What do we have to do to keep what we have? We have a right to a fair and speedy trial but if the courts consolidate it won't happen in a timely manner."




Mayor, council sworn in Wednesday
