Relay goes all night at courthouse

The Relay for Life was held at Norton County Courthouse square on the evening of May 13. Relay teams circled the courthouse until 7 a.m. on May 14. Luminaries lit with candles lined the walk way. The Luminaries marked remembrance of those who had lost the battle with cancer.

The featured speaker, Dr. Glenda Mauer, addressed the crowd gathered on the courthouse lawn before the first lap. She said that she thought of cancer cells as unruly members of society.

"They don't behave themselves." said Dr. Mauer. "They are like gang members that take over an area.'

"I am reminded of Ecclesiastes 3 verse 4, 'A time to weep, and a time to laugh; a time to mourn and a time to dance.' I think today is a time to mourn and also to dance." said Mauer.

The first group to walk around the courthouse square were the survivors of cancer. Before starting off on their lap the survivors announced their name and the length of time they had been free of cancer.

County gives farmer concrete scraps

A farmer will get a couple of loads of old broken-up concrete to help fill a washout in a pasture, Norton County Solid Waste Supervisor Curt Archibald told the county commissioners at the meeting last Monday.

"As long as he doesn't put it on the county right-of-way, it's fine," Commissioner John Miller said.

The other commissioners agreed that the farmer could get the fill at no cost.

Archibald also told the commissioners that he was looking for someone who would recycle the grain sacks that look like giant white worms stretching along the ground.

He said he had thought that the sacks would be reused each season, but found out that they weren't.

"They don't reuse them," he said. "They just slit them down the middle and throw them away."

Right now the empties are coming to the landfill but it would be great to find someone to recycle them, he said.

And speaking of which, he said, there is a recycler planning to visit Norton on Thursday to pick up the plastics that have been saved from the landfill.

Archibald also reminded the commissioners that the landfill is open from 8 a.m. to noon every Saturday.

In other business, the commissioners:

• Heard that the top-coat machine is being used at the landfill.

• Were told that the landfill has received its current household hazardous waste permit from the state.

• Talked about various upcoming county and state meetings and which they could attend and which no one would be able to go to.

• Held a 15-minute closed session to discuss non-elected personnel.

• Looked over the overdue accounts for the landfill.



Norton County has several roads in need of overlays.

Eastern District Road Foreman Floyd Richard gave the Norton County commissioners a list of the three worst roads and the costs of sealing and/or overlaying them.

The Lenora Cemetery Road is the worst, he said. It will cost \$14,850 to seal (5,050 feet) and oil (5,000 gallons at \$2.97/gallon)

The Eagles Road is the second on the list. It will cost \$11,880 to seal (4,074 feet), overlay (890 feet) and oil (4,000 feet).

The E1 Road from Goodyear to the landfill will cost \$8,316 to seal (3,550 feet) and oil (2,800 gallons).

Overall, Richard said, the cost will be \$61,308 including the 300 tons of cold mix at \$77.84/ton for \$23,352 and sand at 600 tons at \$4.85/ton for \$2,910.

"We don't have to do them all at one sitting," Richard said.

The commissioners agreed adding that the Road and Bridge Department should decide the how and when of doing the projects.

"Floyd, you guys figure that out," Commissioner John Miller said.

"It's going to kick the budget, anyway you look at it," Richard noted.

He also said that timing is important. "We want to do it in the hottest part of the year," he said. "July and August would be best, but you have harvest then too."
