

Inexperience a factor for Jays in Regional Golf

The young Norton Community High School varsity golf team showed great improvement this season but it was not enough to qualify any Blue Jay players for state competition in the Class 3A Regional Golf Tournament on Monday in Goodland.

"As a team, our youth and inexperience really played a factor for us in the Regional Tournament today," said Norton head golf coach David Stover.
"We were just not able to adjust to the adversity and shoot a good team score today.
"I am extremely proud of all the golfers who competed for Norton Community High School, not only today but also for the entire season. It is an excellent group

to work with that has shown improvement from beginning to end."
Norton will lose just six seniors from this year's squad: Cole Archer, Ashley Millan, Nikki McVey, Josh Asbury, Katie Gall and Shaylyn Boteler.
Expected to return for next season will be one junior, 15 sophomores and two freshmen.

Hunter Chandler tied for fifth and sixth places in the high jump with a height of 5'4".
Austin Herman took second in the triple jump with 40'8" and then placed third in the long jump with a distance of 19'5.5".
Gunnar Hays placed second in the 1600 meter run with a time of

4:45.41. Hays also placed second in the 3200 meter run in 10:12.8 followed by Jon Compton in fifth with a time of 11:07.22.
Colton Lowry took second in the 800 meter run in 2:04.13.
Matt Callaway placed fourth in the 110 meter hurdles in a time of 17.74 then took sixth in the 300 meter hurdles in 46:14.
The 1600 meter relay team of Austin Herman, Phillip Compton, Hunter Chandler and Colton Lowry placed fifth with a time of 3:47.61.

Gunnar Hays, Austin Herman, Phillip Compton and Colton Lowry took second in a time of 8:48.98.
Head track coach Chuck Fessenden said, "This was the first ever Northern Plains League Track and Field meet. Sixteen teams participated in the meet. We were very pleased with our third place finish behind Lincoln and Rock Hills, both 2A schools. Our strongest events matched up with Lincoln's strengths. They have a great distance runner, a very good long and triple jumper,

and a strong 3200 meter relay team. Therefore, we were finishing second in the events that we normally win. Colton Lowry and Gunnar Hays ran personal bests in their individual races. Jon Compton ran very well in the 3200 meter and set a personal record. Our 3200 meter relay team ran a solid race again this week. Austin Herman continues to jump well in both the long and triple jump. On May 20, we travel to Hays to compete in the 1A regional track and field meet."
