K-9 construction will start soon

On approximately Monday, June 27, construction will begin on K-9 Highway in Norton County.

The road construction project starts at the east US-283 Junction and ends at the Phillips County line, for a total of 12.5 miles.

Workers will place an asphalt chip seal on this section of the corridor. The process consists of placing a thin layer of emulsified asphalt followed by a layer of lightweight aggregate which gets embedded into the liquid asphalt layer. "The new surface is then rolled and swept before being reopened to traffic," explains Kansas Department of Transportation Construction Engineer Jim Riener. "It is a relatively speedy process and the contractor can treat several miles of roadway per day."

Chip seals are a low-cost method of sealing minor cracking in a roadway, blocking moisture from penetrating the surface and therefore extending the life of the pavement.

Flaggers and a pilot car operation will guide one-lane traffic through the work zone during daylight hours. Delays of 15 minutes or less will be expected

throughout the construction time frame.

Please use caution, pay attention to the work zone signs, and respect workers when driving through any road work zone. Slow down and "Give 'Em A Break".

Kansas Department of Transportation awarded the construction contract - totaling \$292,761 - to Heft & Sons, L.L.C., of Greensburg. The pavement repair project is funded by T-WORKS, the transportation program passed by the Kansas Legislature in May, 2010.

Weather permitting, construction work should be completed within a week from the start date.

K-18 Road Construction begins Thursday

Beginning Thursday, June 23, construction will begin on K-18 in Russell and Osborne Counties.

The road construction project starts at the Rooks County line and ends at the west US-281 Junction, for a total of 12.5 miles.

Workers will perform a two-inch surface recycle of the existing pavement, followed by an asphalt seal. "The surface recycle rehabilitates the surface of the existing pavement, and the chip seal will provide a moisture barrier to help extend the life of the pave-

ment," said Kansas Department of Transportation Construction Engineer Jim Riener of the Phillipsburg office.

Flaggers and a pilot car operation will guide one-lane traffic through the work zone during daylight hours. Delays of 15 minutes or less will be expected throughout the construction time frame.

Please use caution, pay attention to the work zone signs, and respect workers when driving through any road work zone.

Slow down and "Give 'Em A Break".

Kansas Department of Transportation awarded the construction contract totaling \$1,178,990 to Dustrol Inc., of Towanda. The pavement repair project is funded by T-WORKS, the transportation program passed by the Kansas Legislature in May, 2010.

Weather permitting construction work should be completed by mid-July.
