# Blue Jays finish fourth in basketball tourney

Coach Doug Reusink's Norton Community High School's boys basketball team placed fourth in the very competitive 23rd annual Topside Tip-Off Tournament held last Thursday, Friday and Saturday in Goodland.

In their first game of the season and the tournament, Norton defeated Sharon Springs 48-44 to advance in the championship bracket. In the semi-finals on Friday, they met eventual champion Ottawa and lost 77-28. In Saturday's third place game, they lost a close 49-41 contest to

Also on Saturday, Ottawa defeated McCook 72-49 for the title, Burlington outscored Weskan 34-29 for the consolation championship and Wray defeated Sharon Springs 62-53 for seventh place.

Norton senior Jordan Wahlmeier was named to the All-Tournament Team for the second year in a row. Also on the team were Semi Ojeleye, Dallas Natt, both of Ottawa; Sam McKinney, Weskan; Preston Talbert, Wray; Clay Schemm, Sharon Springs; Matt Chitwood, Matt Collicott, both of McCook; Ryan Hillmer, Goodland and Stetson Corman, Burlington.

Hillmer won the three-point contest. Ottawa won the free throw award with 45 of 65 for 69 percent and Ottawa's cheerleaders won the Spirit award.

## **Sharon Springs**

In Norton's opener with Sharon Springs on Thursday, the Blue Jays trailed 18-10 after one quarter and 28-21 at halftime but dominated the third quarter where they outscored Sharon Springs 16-2 to take a 37-30 lead into the final stanza. They were outscored 14-11 in the final period but still won 48-44.

"I was a little disappointed early in the game when we panicked on both offense and defense," said coach Reusink. "Turnovers hurt us.

"In the third quarter, we did a nice job defensively and hit enough shots along the way to get the lead. We played well in the third quarter. We didn't finish shots very well in the fourth period. We were getting good shots but just not finish-

Leading scorer for Norton was senior post Jordan Wahlmeier. He hit 8 of 18 two-point shots for 44 percent and was 3 of 5 at the free throw line for 60 percent and 19 total points. Junior forward Jacob Brooks hit 10 points on 4 of 9 two-point shots for 44 percent and 2 of 2 free throws. Senior forward Dillon McConney hit 8 points on 4 of 5 two-point tries for 80 percent.

Senior guard Tye Nickell tallied 7 points on 1 of 1 from beyond the arc, 1 of 2 two-point tries and 2 of 6 free throws for 33 percent. Senior guard Zach Hartwell added 4 points on 2 of 3 two-point shots for 67 percent.

As a team, Norton hit 1 of 5 from beyond the arc for 20 percent, 19 of 41 two-point tries for 46 percent and 20 of 46 overall for 44 percent. Sharon Springs hit 1 of 13 trey tries for 8 percent, 16 of 28 two-point attempts for 57 percent and 17 of 41 overall for 42 percent.

Norton was 7 of 13 on free throws for 54 percent and Sharon Springs hit 9 of 17 for 53 percent.

caroms and Sharon Springs pulled down 4 offensive and 18 defensive rebounds.

Leading rebounders for Norton were Brooks, Wahlmeier and McConney with 6 each, followed by Nickell, 5; Joe LeClair, 3; Andrew Ellis, 1; Carson McKenna, 1.

Norton had 2 steals and Sharon Springs had 6. The Blue Jays had 4 assists compared to 1 for Sharon Springs. Nickell had 2 assists, Brooks and Wahlmeier, 1 each.

The Blue Jays had 10 turnovers and their opponents had 16.

### Ottawa

Norton played Ottawa on Friday in the championship bracket. They had easily defeated Burlington in the opener and had no trouble outscoring
