# Norton to compete in Newton Tourney

nortontelegram@nwkansas.com The Norton wrestlers will face their biggest challenge of the season this Friday and Saturday when they compete in the prestigious 49th annual Newton Wrestling Tournament of Champions in Newton.

A total of 25 teams will compete in the tournament. In addition to Norton and Newton, the teams are: Andover Central, Ark City, Bishop Carroll, Colby, Derby, Dodge City, Emporia, Fredonia, Garden City, Gardner-Edgerton, Hutchinson, Lawrence, Leavenworth, Liberal, Maize, Maize South, Manhattan, McPherson, Mill Valley, Salina South, Wichita Heights, Wichita Northwest and Tulsa, Okla. Union.

Norton is the smallest enrollment school to ever win the Newton tournament championship. The Blue Jays won the team title in 2005 and 2006 and did not compete in 2007 due to inclement weather. In 2008 and 2009 Norton finished ninth as a team and in 2010 placed fifth out of the 25

teams competing. Last year, the Blue Jays turned in an outstanding fourth place finish.

Wrestling will begin at 11 a.m. on Friday and 9 a.m. on Saturday. Admission is \$7 for adults and \$5 for students K-12 per session. A two-day adult ticket is \$12 and two-day children's ticket is \$8.

Junior varsity at Elm Creek On Friday, the Norton junior varsity wrestlers will compete in the annual Elm Creek Invitational Wrestling Tournament in Elm Creek, Neb.

Wrestling will begin at 2:30 p.m.

Entered, in addition to Elm Creek varsity and Norton junior varsity, will be varsity teams from Alma, Arapahoe, Medicine Valley, Overton, Pleasanton and junior varsity teams from Burwell-Sargent, Cozad, Gibbon, Holdrege, Lexington and Southern Valley. Two team trophies will be pre-

sented along with four individual medals in each weight division. Admission will be \$5 for adults

and \$4 for students.
