

RESOLUTION #118

WHEREAS there has been a prolonged period of no rain in the City of Norcatur; and,

WHEREAS during the upcoming period of time, the sale of fireworks will commence in the area; and,

WHEREAS the discharge of fireworks could very easily cause a fire or conflagration within the City of Norcatur; and,

WHEREAS the Mayor has entered his disaster declaration banning the discharge of fireworks in the City of Norcatur,

NOW THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF NORCATUR, KANSAS:

Section One. Pursuant to the powers granted to cities under KSA 48-932 we do hereby consent to the Mayor's order and declaration that an emergency exists or is imminent and that the discharge of fireworks within the City of Norcatur is hereby prohibited.

Section Two. The Mayor's order shall be and remain in effect until dissolved by the governing body.

Section Three. Pursuant to KSA 48-939 a violation of this order is a class A misdemeanor punishable by up to 1 year in jail and/or a fine of up to \$2500. ADOPTED BY THE COUNCIL and APPROVED BY THE MAYOR on this 28th
