# Wildlife and Parks asks for your vote

#### Support Constitutional Amendment

Vote YES on the watercraft constitutional amendment November 6. The airwaves and our mail boxes are full of information about the candidates in the upcoming election. But also important is a constitutional amendment that - if passed - will allow for fairer taxation of watercraft (boats) and make Kansas watercraft taxation competitive with surrounding states. Some voters may ask, "Why should I care?"

Property taxes on watercraft in Kansas are so high that they impede boat ownership, limiting families' opportunity for wholesome water recreation. Compared to surrounding states, Kansas watercraft property taxes are so high that many Kansans register their boats in neighboring states, so Kansas counties lose property tax revenue. The high tax rates also reduce in-state boat sales, impacting our marinas, boat dealers, and reducing state sales tax revenue.

The legislature showed bipartisan, overwhelming support - 121 to 2 in the House and 40 to 0 in the Senate - for placing this amendment on the ballot. The amendment may be difficult to understand because the ballot includes the entire article of the constitution that is affected, not just the change. The only change is the addition of the words "and watercraft." Adding just those two words will give the legislature the opportunity to create a fairer tax treatment of watercraft. You can give them that opportunity by voting YES.

This change is good for Kansas and Kansas families, and we encourage you to vote YES on the amendment.

## Keeping the new pool tax proposal a separate issue

need of replacement, I agree. However for in 20 years or less, the .75 percent we need, as a community, to get the financing right. The pool needs to stand on its own merit.

The way the city has the ballot issue worded, this is not just for a pool, but almost any other capital improvement or expense. When the pool is paid off, the sales tax will not sunset, unless, the council approves it. Right: when was the last time they ever decreased our taxes: If the pool sales tax proposal was for a new pool, it should be for exactly that--Increase the sales tax .75 percent to build a new pool--and when it is paid

sales tax sunsets: Period.

If the city has other financing concerns according to the ballot "and to finance general operating and capital improvements of the city," they need to present that as a separate issue. The city has paid for the operation and maintenance of the old pool, they can certainly budget for the operation of the and tough decisions by all. new pool, not from this new tax.

This ballot proposal is a rotten apple dipped in carmel. It looks good at a glance, but the apple is still rotten, and if this ballot measure passes we will get to eat the whole apple.

Make the city get the pool funding issue right, that the new tax is for the new pool. It may take a little longer but it will be worth the wait. Then, we can all support and appreciate the new swimming pool!
