Doyle L. Foss

Doyle L. Foss, son of Arthur and Enid (Griffith) Foss, was born Dec. 26, 1919 in rural Norton County, and passed away at his home in rural Edmond, on Nov. 18, 2012 at the age of 92.

Doyle grew up in Norton County, attended rural grade school, and graduated from the Edmond High School. He also attended Kansas State University for one year. Doyle moved to Wichita, where he was a template maker at Beech Aircraft, before entering the U.S. Navy.

He served his country during World War II. On Feb. 6, 1946, Doyle and Arlene Adams were united in marriage in Clayton, and they lived in San Diego, Calif., until Doyle's discharge from the Navy.

Following his discharge, they returned to the Edmond area to farm and raise their family. Doyle was a member of the Edmond United Methodist Church and served as the Sunday School Superintendent for many years. He had also served on the Edmond Grade School board. Doyle enjoyed baseball and played the harmonica in the band at school.

He loved his family and enjoyed spending time with them.

Survivors include: his wife, Arlene Foss, Edmond; three daughters and their husbands, Joan and Nicholas Pasch, Belleview, Wash.; Barbara and David Altwegg, Wamego; Janice Foss and Peter Gutterman, Pinole, Calif.; three grandchildren; five great-grandchildren; other relatives and many friends.

Doyle was preceded in death by his parents and his brother, Gene.

She was also a gifted floral designer and skilled cake decorator. Following the closing of her store she started china painting and decorating and won many awards for her beautiful work. She was a member of the China Painting Chapter in Wichita.

Competitive by nature she enjoyed playing bridge and was in several bridge clubs as well as being an avid golfer. She was a member of the Manhattan Country Club and played in numerous golf tournaments both locally and out of town. Ruby lived life to its fullest. She loved to dance, entertain family and friends in her home, was a wonderful baker, loved to



travel, and even went snow skiing for her first time when she was in her 70's and snorkeling when she was in her early 80's. Her wonderful sense of humor and kindness was reflected in all that she did. Most of all she adored her family, especially her grandchildren. She was a very devoted grandmother who was very much involved in her grandchildren's lives. When the grandchildren were younger they often times spent spring break and summer vacations with their grandparents, who made sure they stayed busy with activities, and enjoyed traveling with them to wonderful vacation destinations.

Ruby was a member of Seven Dolores Catholic Church. She loved God and enjoyed attending church with her family.

Living most of her lifetime in Manhattan rapidly turned her into a true Kansas State sports fan. She and her husband enjoyed attending all football and basketball games, including out of town games and numerous bowl games.

Following her husband's retirement they began wintering

in Scottsdale, Ariz. with an occasional winter spent in southern Texas.

She is survived by her husband of 70 years, Leo Theodore Wendling, of the home, and by their son: Phillip L. Wendling and his wife Darlene of Richardson, Texas. Also surviving are four grandsons: Cory Wendling (Lindsay) of Wylie, Texas; BJ Wendling (Stacy) of Prosper, Texas; Ryan A. Wendling of Plano, Texas; Phillip Trevor Wendling of College Station, Texas; and two great grandchildren: Parker and Piper Wendling of Prosper, Texas. Tips for donating, to avoid scams

In light of the devastating storm system that hit the east coast last week, Kansas Attorney General Derek Schmidt warns Kansans to be aware of possible scam artists seeking to profit from the generosity of others.

Schmidt warns the public to make sure they are donating to a reputable charity and to specify that a charity uses donations for intended purposes.

"When natural disasters strike, it is human nature to offer help," Schmidt said. "But, please donate wisely to established, legitimate disaster-relief charities."

Here are a few simple tips for donating, to avoid being scammed:

Make donations to established organizations with a strong track record of organizing and providing disaster relief.

Initiate the donation yourself, rather than responding to online or phone solicitations.

Avoid door-to-door solicitors or offers from charities to stop by a consumer's home to pick up a check. These too could be fraudulent.

Do not fall prey to high-pressure pitches from solicitors. Legitimate charities allow you time to think about how much - and when - you choose to donate.

Be wary of charities that ask for alternate forms of payment. Legitimate charities rarely if ever ask you to give by wire transfer.

Prepare to keep food safe during a storm

The recent hurricane and blizzard on the east coast and other major storms where power was lost, brought to mind the need to again address what to do with stored foods in a power outage.

The loss of electrical power can cause perishable foods to become unsafe to eat. To get ready before winter storms arrive, follow these tips: Put an appliance thermometer in your refrigerator and in your freezer. Stock enough pantry food to last for several days of not cooking or cooling. Have a hand-held can opener. If your freezer is not full, fill it by freezing some water in clean plastic bottles with secure lids.

If you lose power, put some bottles of ice in the refrigerator. Note what time it is and avoid opening the refrigerator or freezer until power is restored. If you keep the door closed, a

refrigerator will keep food cold for four hours; a full freezer will stay cold for 48 hours; and a half-full freezer will stay cold for 24 hours.

When the power is back, check temperatures of the refrigerator and freezer. If the power was out for more than four hours, or the door was not kept shut, discard any perishable refrigerated food (including meats, poultry, seafood, eggs, milk, soft or shredded cheeses, and leftovers) that was kept warmer than 40 degrees F. for two hours or longer.

For foods in the freezer, you may safely refreeze ones that contain ice crystals.
