Price increases at 4-H building

The prices to use the Norton County 4-H building will go up a bit next year to help pay for increasing expenses and some hoped for renovations.

The county 4-H building needs new lights and some curb and gutter work done, Gil Otter, a spokesman for the 4-H Building committee, told the Norton County commissioners on Monday during their weekly meeting at the courthouse.

The old inside fixtures, he said, are obsolete and bulbs will the City of Norton. become increasingly hard to get.

Mr. Otter also presented the Commissioner John Miller commissioners with an updated payment schedule for the building noting that it had been four years since the prices were changed and that the new prices were reached after reviewing the utility, insurance, supplies and janitorial costs for the building.

Commissioner Carolyn Applegate said she thought the new prices were about right.

He said it isn't possible to cover the costs of unoccupied days and there are a lot of unpaid useage days when the Norton County Extension, Boy Scouts, Ministerial Alliance or agricultural groups use the building.

Mr. Miller noted that there is a lot of unpaid useage of the building.

"There's a lot of benevolence going on," he said. "There's no way for the paying entities to America's credit card. cover for the non paying."

Mr. Otter said that the guidelines for use of the building will be posted by the door and also given to anyone getting the key. In the past, there have been some problems with cleanup after events.

The commissioners agreed that this was a good idea and authorized the changes for 2013.

America's Debt: No laughing matter

"Are you kidding me?"

That was all I could think to myself when I heard that U.S. Treasury Secretary Geithner said that the U.S. "absolutely" should get rid of the debt ceiling, which is the limit on federal government borrowing.

Having served in Congress for two years now I thought that I had heard it all from the Obama Administration, but it appears they have not run out of senseless ideas. At a time when America is more than \$16 trillion in debt - an amount about equivalent to the size of our entire economy - the last thing we need is to remove the cap on

Two years before becoming President, then-Senator Barack Obama declared it "unpatriotic" to raise the debt limit. It was probably one of the few times we have been or ever will be on the same page. Yet, as we come to the conclusion of his first term as President, present and future taxpayers are on the hook for \$6 trillion more debt and are likely to be responsible for at least \$4 trillion more come the end of his second term.

Despite the \$6 trillion more debt in his first term, the Obama Administration will come to Congress in a matter of weeks and ask that we raise the debt limit. Or, apparently as Secretary Geithner has suggested, get rid of it altogether.

The unfortunate reality is that Congress will have to raise the debt limit. That is what happens when Washington borrows 40 percent of what it spends. But, this time the conditions have to be different.

Another deal like the one that was cut by Republicans and Democrats in August 2011 cannot be on the table. Sixteen months after that arrangement, Washington has almost exhausted all of the borrowing, but has not a single cut yet to show for it. The cuts are set to take place on January 1, 2013, but the odds are high that lawmakers on both sides of the aisle will find a way to finagle out of them.

As it was 16 months ago, the problem in Washington is not that we do not take in enough money. No, the problem is still that we spend too much. Perhaps I sound like a broken record writing that month after month. but Congress and the President have yet to deal with the out-ofcontrol spending.

Voters may have sent mixed messages to Washington by reelecting a Democrat President with a slim 51-percent margin and a Republican-controlled House (where the Constitution prescribes all revenue bills must originate), but exit polls from on Election Day show a pretty clear mandate on the policy direction of Washington: it is time to tackle spending.

Nearly two-thirds of voters said "no" to raising taxes to fix the deficit (meaning spending cuts are the way to go), and by an eight-point margin voters said "government is doing too many things better left to businesses and individuals" rather than "government should do more to solve problems." Americans are not looking for higher taxes and more government; they are looking for less of both.

If the next "debt deal" is anything like the last - guaranteed debt, uncertain spending cuts - I will again ask: "Are you kidding me?" After all, more debt and more spending is no laughing matter.

antifreeze to spill out all over the motor and under the bus. The bus was sitting over a gas tank (at the co-op) so had to be moved."

A wrecker was called and the bus was moved over to the senior citizens center, she said.

Mrs. Pabian said that she had been checking on getting a backup bus or van but that she couldn't apply for one until April or May and it wouldn't be delivered until 2014.

Commissioner John Miller suggested that she check to see if a 1992 ambulance, which is not being used right now but which the county is keeping for a backup, might be used.

Mrs. Pabian went to check

on the bus after talking to the commissioners but found that it won't accommodate wheelchairs and is probably not big enough for the number of passengers the bus usually carries.

Commissioner Miller asked if the county might sue Lewis as the insurance will not pay for any repairs or replacements since there was no accident.

Commissioner Carolyn Applegate suggested a state-wide appeal for a replacement.

Mrs. Pabian said that she has found some vehicles in Salina and Kearney, Neb., that might work but they run from \$20,000 to \$50,000 and none have lifts although some have ramps that accommodate wheelmight chairs.

Mrs. Pabian said that she has three people in Almena in wheelchairs including one who needs to come to Norton three times a week for therapy.

Mrs. Applegate said that the county needs a bus. While it is considered a senior bus, she noted, it is really for everyone. Only about 40 percent of those who use it are seniors, she said. The rest are people without transportation or the disabled.

"Almena and Lenora really rely on the bus," she said.

Mr. Miller said he would call the county's lobbyist in Topeka and see if he could get anything done on the project.

The commissioners also discussed the problem with County Attorney Doug Sebelius.
