Lucille E. Leitner May 15, 1927 - Jan. 7, 2013

Lucille E. Leitner, 85 years of age, of Concordia, passed away unexpectedly Monday, Jan. 7, 2013. She was born May 15, 1927 in Thayer County, Neb. to Leonard and Martha (Schutte) Dankenbring.

She graduated from Bruning High School and received her business degree from National Business Institute in Lincoln, Neb. She first worked for an attorney in Bruning and then decided to follow her parents to Goodland, where she was employed by BE Bridges and ultimately met her future husband, Bill Leitner. They were married Sept. 7, 1947 and lived in Goodland until August 1977. Bill's job moved them to Norton, until his retirement when they moved to Bennington to be closer to 'the kids' where she was actively involved with the United Women With a Mission (UWWM). After Bill's death in October 2004, Lucille moved to Concordia to be closer to her daughter Shari and family.

Lucille was preceded in death by her parents and husband, Bill.

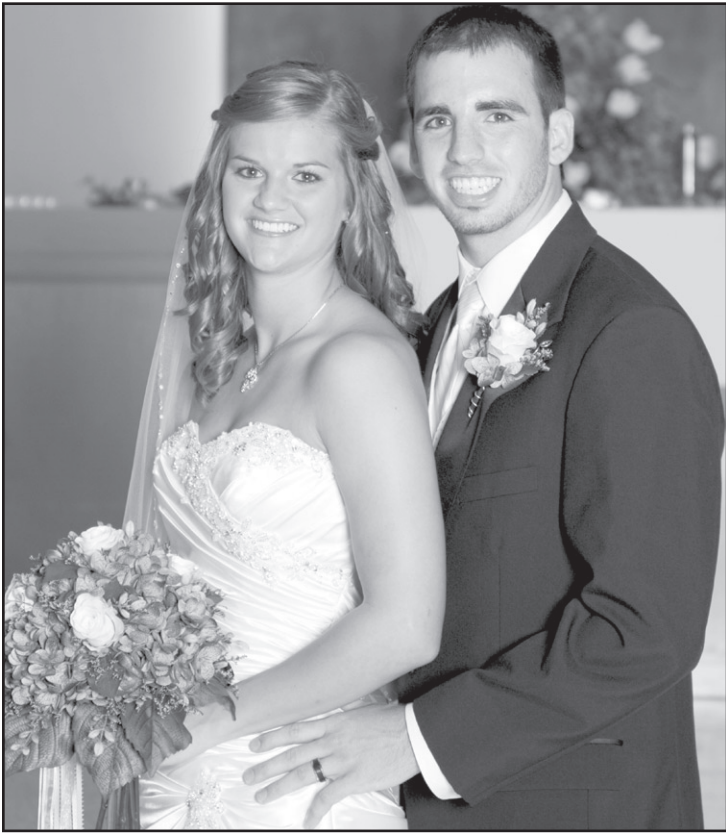
Wedding Announcement
