# County faces issue involving transports

One word makes a difference in how a patient is handled by various state and county agencies, Norton County Hospital representatives were told at a meeting with the county commissioners, emergency medical service workers, county attorney and sheriff's de-

If a patient goes to the hospital and is reported to have psychiatric issues, they are considered to have a non-emergency problem and cannot be transported by the ambulance. However, if a patient is believed to be suicidal and be a danger to either themselves or others, they then fall into a different category.

Hospital Administrator Rich Miller cies get together during a commission the hospital had in January.

A patient came in to the emergency room at 6:30 a.m., he said, and the hospital personnel couldn't get anyone to take them to Hays for treatment despite calling both the Norton ambulance service and the sheriff's office. The hospibe considered taxi service and third-hospital twice that day, the sheriff said. ty Emergency Medical Service and the patient was sent to Hays at 3:30 p.m.

Mr. Miller said that he has since checked with the Ellis County service and discovered that they have not been paid for the transport. While Ellis County has not asked the hospital to pay them, he said, he feels that they need to be paid because Norton may need their help again.

Norton Emergency Medical Service Director Jane Wyatt said that since the patient was at the hospital, they were classed as non-emergency and her service could not transport them per county protocols. However, she said, Ellis County might have different rules.

She said that an ambulance can be used to transport patients, who have been involuntarily committed, to the Larned State Hospital but only if that can be done safely for all concerned.

There are so many hoops to jump through, she said, the ambulance can't transport patients, who do not have an emergency because then it would just

Sheriff Troy Thomson told Mr. Miller that his department has an agreement with the Norton City Police that the police will take care of anything within the city and the hospital is inside the city limits. The calls to the sheriff's office were

turned over to the police, he said, but since the officer was calling from the sheriff's office, the hospital thought they were talking to the sheriff instead of the police.

Again, the word psych patient was used, he said, and they were not told that the patient might be suicidal and a danger to himself or others. The difference is that a person who comes into the emergency room under their own volition for help is a voluntary commitment and again not considered an emergency. If someone is considered suicidal or a danger, that is a police

The police spoke to people at the

tal finally got help from the Ellis Coun- party payers (insurance companies, However, law enforcement can't take voluntary commitments because again that would be considered a taxi service and is outside what they are supposed

Both Mrs. Wyatt and the sheriff expressed concern and said that they felt badly about what had happened and did not want the hospital to be in the middle of a controversy but said that they are constrained by what they can

"I'd like to see a solution so it doesn't happen like this again," Mrs. Wyatt told Mr Miller

County Attorney Doug Sebelius explained the laws which the sheriff, the ambulance and his office operate under and said that he would not be in favor of the county paying for the Ellis trans-

"It's not Norton County's expense," he said. "I couldn't authorize a vouch-

# It all boils down to the cost of things

The Norton County Road and Bridge Department is changing its engineering firm from B&G Engineering to Penco for bridge inspections.

Road department Supervisor Sandy Smith told the county commissioners on Monday that B&G has just become more and more expensive over the years and, while the county will still be using them for many things, Penco has a better price for bridge inspections.

The county has 195 bridges, she said, but not all are inspected every year. By switching to Penco, she hopes to save about \$7,000 a year on inspection fees. In 2010, B&G charged \$112 a bridge and in 2012, the cost was \$115. Penco will cost about \$80 a bridge, she said.

Ms. Smith said that all the new road graders, the county has just purchased, have arrived and that the crew is delighted with them. However, she said, she did not buy an upgraded mainte-

nance contract on the machines because it was just too expensive for what it covered.

She said that the crew had spent some time Monday morning in a safety meeting, which was good because the fog would have hindered work anyway and that she has hired a new equipment operator. He will start on May 1, she

In other business, the commission-

• Decided to help with the annual spring city-county cleanup with the City of Norton. It costs about \$4,600 for the cleanup, County Solid Waste Supervisor John Miller told the commissioners. Each year, the City of Norton has both a spring and a fall cleanup, he said, but the county only helps out with the spring one.

• Authorized the road and bridge department to go to a 10-hour, four-day work week. The crew will work from 7 a.m. to 5:30 Monday through Thursday from May through the beginning of September. The change should give the crews more time on the roads and less in traveling back and forth, Ms. Smith told the commissioners, noting that the biggest day for calls is Tuesday with Friday getting the least calls for road

· Visited with Len Coady, who talked to them about First Central Insurance, which handles health insurance for all Kansas companies except Blue Cross and Blue Shield. Mr. Coady told the commissioners that he was sure he could save the county money without changing its benefit package but would need the health history for its workers. That will not be available until June, County Clerk Robert Wyatt said. That is when the county starts work on health insurance benefits for the next year. Right now, the county has Blue Cross for its health insurance, he said.

## Norton man to face charges of rape this May

Winningham is being charged with felony rape of a 17 year old female. The alleged assault is reported to have taken place on Feb. 19, 2012. The alleged victim in the case was a minor at the time and her identity remains anonymous.

The defense attorney for Winningham has requested a continuance of the preliminary hearing which will be heard on May 2, at 9:30 a.m. in District Court. Winningham is currently being held on \$100,000 bail.

During the preliminary hearing the Court will review the evidence in the case and determine if a crime was committed and establish if there is probable cause to believe the defendant committed the offense.
