-Chief of Police Pat Morel stated that the Click-it or Ticket campaign will run from May 20 through June 2.

-City Administrator Rob Lawson reported that Cornerstone Contractors have started work on the Gower building located at 109 E. Main Street and said the City will leave the fence up to keep people out for safety reasons.

Norton already has 28 approved applications and another four are in the process, he said.

The county puts up \$40,000 and last year the state put up another \$40,000 to help relieve student loans and for business enterprises, he said. The program is for five years with the state promising to pay \$27,000 a year. However, Mr. Sproul said, he hopes to get another \$40,000 from the state because the Norton program is going so well.

In other economic development business, he said, the Ag Valley road project is in the final design stage and the economic group is helping the City of Almena with a housing assessment tool, which it can use to get housing grants and loans. This will help employers in the area because potential employees will have a place to live.

When the group gets done with that, it will start work on one for Lenora, Mr. Sproul said.

Mr. Sproul said that his group is working on several things and that the new housing units are coming along well.

Local Norton woman pleads guilty in case

Norton resident and former McDon--Lawson also reported that the inmate ald's employee Samantha Rojas pled guilty to forgery and five counts of theft in District Court on Monday, May 13. The forgery conviction is a level eight felony and the five counts of theft are class A misdemeanors.
