Once the plans were made Mick and Colette Miller drove to Brownsville along with Dave

Gilgenbach to bring them to Norton. Mick coordinated the moving of the statues to the truck owned and driven by Gilgenbach. Keep in mind, this is no small task. "And I couldn't have done it without them," she stated

As Gilgenbach drove the statues back to Norton, he was stopped by highway patrol, not because he was doing anything wrong but because the officer knew what they were and wanted pictures of them. A while later down the road, he was stopped again by another highway patrol officer for the same reason. "Needless to say, they caused quite a stir." Sue said.

Once back in Norton, Roger and Linda Fuller of Rawhide Ironworks completely refurbished the statues, taking them back down to the original bronze and re-did them. Thanks to Mick and Colette Miller, on

Friday, September 6 they were put on concrete platforms that had been poured for them by the City of Norton and anchored to the ground. Sprinklers had to be moved, lighting put in place as well as cameras. The only thing left to do is the dedication which will take place on October 22 at 5:30 p.m.
