New Road and Bridge Office Manager Becky Wilson does not live in the county and, although she is looking to move here, she told the commissioners it's tough to sell her home and find a new one.

"If we have a big snowstorm and the ambulance has to go out, we will need to know," Road and Bridge Foreman Floyd Richard said.

Commissioner Charles Posson suggested that perhaps one of the weed department employees could help out in case of an emergency.

In other business, the commissioners:

• Heard that there was a request for two miles of shale to be put down on Road E11. The road is an old field access road, Mr. Richard said, and its probably not practical to do that.

• Learned that one of the road and bridge tractors is in the shop again. This machine has been in for repair numerous times and the commissioners thought it needed to be replaced.

• Were told that there is a prison crew out removing guard rails on Road E8 in preparation for repairs. The crew will move on to road E9 to remove guard rails on it later, Mr. Richard said.

• Mr. Richard said that he had three applications for a road job, had held interviews and hired Mark Retke for the job. He will start the first of the month, Mr. Richard said but still has to get a CDL at his own expense.

• Talked with County Health Nurse Gina Frack about getting

her department authorized to use Facebook. Mrs. Frack said that only the sheriff's department and emergency preparedness is authorized by the county to use social media but many of the health departments in other counties are using it now to get information out such as how to protect yourself from West Nile disease.

• Set 9 a.m. Monday, Nov. 4, for a one-half hour presentation by Mrs. Frack on "Work Well Kansas," a program the health department is promoting.

• Decided to forgo their Monday, Nov. 25, meeting and hold the weekly and end-of-themonth meeting on Wednesday, Nov. 27, since the county takes both Thanksgiving and the day after as holidays.

• Decided to offer county employees a chance to purchase a \$35 membership in a fixed-wing air ambulance service out of McCook.


