# hours on Thursday City council discusses many items

Norton City Council President Roberta Ryan presided over the meeting on Wednesday, Nov. 20, with Mayor Corns arriving later.

Ryan reported that the total economic impact for the Norton area from the Governor's Ringneck Classic was estimated at \$180,413. She also reported the city general sales tax receipts collected in October totaled \$21,030.76, the city pool sales tax receipts totaled

\$31,546.15, and the county sales tax receipts totaled \$13,931.87 for a total of \$66,508.78, and the 2013 year to date sales tax receipts total \$621,721.07.

The council approved to sell engine parts and miscellaneous items from the Cooper engine at the power plant to the City of Beloit for a proposed price of \$35,000, unless the air compressor from the engine can be used by the City of Norton. If the City can use the compressor the price would be reduced by

All future street signs in Norton will have to meet new regulations, according to Donna Foley. The Public Works committee discovered that if any street signs are replaced, they have to meet the new regulations. Public Works supervisor Dan Bainter is working on a plan to acquire the materials for the new signs and how much it will cost to replace the signs in 2014.

Foley also reported that the Parks Committee will meet with the Norton Recreation Commission to see if the Commission would be interested in overseeing the Norton Municipal Swimming Pool. The Parks Committee will decide on the equipment to purchase for the pool project.

In other council news:

-approved using Hansen Foundation funds to pay for the handicap accessible doors on the Norton Public Library and Northwest Kansas Library System. The total owed for both doors

The Board of Education, U.S.D. 211, voted unanimously to extend the contract of Superintendent Greg Mann through the 2014-15 school year at last week's Monday meeting. Mann's salary and benefits will be determined by the board at a later date.

Also, Superintendent Mann reported to the board that the next meeting of

the Facility Study Committee will be Nov. 18., and that bus number 14 had a cracked turbo and was towed to Kearney, Neb., and repaired and is back in service. Mann also gave a State Assessment update, a budget update, a breakfast usage report, and that the current Local Option Budget computation formula will sunset June 30, 2014, if not extended by the State Legislature.

ported that the Norton Junior High School and Norton Community High School music program on Oct. 24 was a great success. Karnopp also thanked all the veterans that work in the district for their service to the country and to those who have family members currently serving in the military.

# County treasurer's office gets updated look

cynthia.haynes@nwkansas.com The Norton County Treasurer and her crew should be sitting pretty once their new furniture arrives.

Treasurer Cynthia Linner has been looking to get new workstations and chairs for her office for several months. At the county commissioners meeting on Wednesday, Mrs. Linner presented a bid from End Zone Sports and Office Supplies of Norton for three workstations for \$12,321 and three chairs for \$1,260. The old furniture from her office,

she said, will be moved over to the appraisers office. That office, Mrs. Linner said, is in need of more workstations, but does not have the budget to buy any

The bid would include setup for the furniture in both offices, she said, but does not include removal of old furniture from the appraisers office.

"So basically, we would be equipping two offices," Commissioner Charles Posson noted.

Commissioner R.A. Peterson said that he thought that \$4,000 a workstation sounded really high.

Mrs. Linner pointed out that one of the chairs in her office fails regularly with the occupant suddenly sinking out of sight as the pneumatics fail.

The new furniture would allow customers to sit down instead of standing, she said. With the new pad that records signatures for people dealing with motor vehicles, it makes it more comfortable for them while they are signing and helps so that the treasurer personnel do not have to continually move the signature pad from place to place all

Commissioner Posson said that this

sort of thing is expensive. "Really good workstations are really

expensive," he noted. Commissioner Peterson excused himself for a short time while he went over to the treasurers office to see what
