### Norton wrestlers place third at Clay Center

Although the Blue Jays are ranked No.1 in the state in Class 3-2-1A, they were up against some very talented wrestlers of top ranked teams in larger en-

Holton, who is No.1 ranked in Class 4A, won the championship with 141.5 points. Runnerup with 135 points was Garden City, No.1 ranked in Class 6A. Norton scored 124.5 points.

Junction City, No.2 state ranked in Class 6A, finished fourth with 106.5 points, followed by Marysville, 88.5; Beloit, 68.5; Clay Center, 49; Hoxie, 42; Salina South, 37; Rock Creek, 28.5.

Norton entered 10 of the 14 weight classes.

Three Blue Jays won individual championships: Jared Tallent, 145; Cole Renner, 170 and Jacob Green, 220.

Placing runner-up for Norton were Caysean Campbell, 106 and Branson Addington, 113.

Finishing in third place were Toby Nickell, 132 and Alec Hager, 138.

Gavin Lively, 152, placed fifth, Michael Johnson, 285, finished sixth and Kendall Miller, 160, was seventh.

The Blue Jays compiled a 31-12 win-loss record and had an 18-4 pin ratio. Norton was 11-6 on two-point near falls, 20-4 on three-point near falls and 50-19 on two-point takedowns.

### Wrestler of the Week

Cole Renner and Jared Tallent were named "Co-Wrestlers of the Week" by the Norton coaches.

"Cole had four pins and one tech fall and was very dominating," said Norton head coach Bill Johnson.

"Jared had four wins, one by a pin and one a major decision. He showed toughness in wrestling through a quality bracket." Coach's comments

"We knew this tournament would be extremely tough and it was," said coach Johnson.

"A round robin tournament where you have to wrestle all the good wrestlers made it a learning experience for us. We dropped some matches that we shouldn't have and made some mistakes but I was fairly pleased with the overall team performance. We entered ten wrestlers and five made the finals."




