BB Gun Team takes first at **4-H Regionals**

nortontelegram@nwkansas.com The Norton County Rotary BB Gun Team started their 2014 year competition in a championship way on Saturday, Feb. 22 by running away with the title in the Logan County 4-H Regional BB Gun Shoot in Oakley.

Norton County won the championship with a total score of 1421 and 31 bull's eyes by their top four shooters in the prone, standing, sitting and kneeling positions.

Thomas County was runner-up with a score of 1355-26x, which was 66 points behind. Third place went to Phillips/ Rooks Counties with a 1349-26x, followed by Golden Prairie (Logan, Trego, Gove Counties), 1331-27x; Rawlins County, 1242-16x; Ellis County, 1219-20x; Sheridan County, 1006-10x.

Team scores were comprised of the top four shooting scores for each team.

Marksmen competed in either the 7 to 9 year old, 10 to 11 year old or 12 to 14 year old category. All shooters who scored at least a 325 shooting score qualified for the State 4-H BB Gun Shoot to be held on Saturday, April 12 in Alma.

Norton had nine state qualifiers out of 15 who entered. The top shooter for any age was first time marksman Lily David of Norton County with an 89 prone, 88 standing, 94 sitting, 91 kneeling for a total score of 362x7 in the 10-11 age group.

Second high scorer from Norton County and the top shooter in the 12-14 age group was Stacie Elliott with a 90 prone, 84 standing, 92 sitting, 90, kneeling for a total of 356x10.

Dylan Goss of Norton County, also in the 12-14 category, was second prone, 90 standing, 90 sitting, 91 kneel- of 344x6. ing, 355x7.

Meeting held for school bond issue

About a hundred people attended the U.S.D. 211 School Board's community meeting on Sunday at the East Campus Auditorium to discuss the upcoming bond issue election set for April 1.

The meeting was broadcast live on KQNK Radio, as Superintendent Greg Mann explained to the crowd the reasoning for the bond election, why the money is needed and how it will be spent.

The school board has recommended a bond issue amount of \$14,825,000 for numerous proposed capital improvement projects at the high school, junior high and elementary schools, and other district properties. The bond issue is based on a 20 year payback. The proposed 2014 bonds will require a mill levy estimated at 14.99 mills. A mill is a \$1 tax on each \$1,000 of assessed valuation of property located in District 211. In other words, if you own a \$75,000 home your estimated tax increase will be \$10.77 per month or \$129.29 per year.

"There is never a good time to raise taxes," said Mann, but he pointed out that there is a window of opportunity that may not be available later. At present, state finance formula allows additional state aid to pay 33 percent of the project cost and interest cost on a voted bond issue. The total state aid benefit (both principal and interest) is estimated at \$7,558,000, which would come from Topeka to help pay off the bonds. Mann said Governor Brownback has proposed an end to this state aid program for future bond issues, so now may be the last opportunity to take advantage of this program that offers to pay one-third of the cost. Without the current state aid assistance the proposed

necessary because education requirements have changed. Programs such as Title I Reading and Math, Special Education, At-Risk support, speech and language services, and physical and occupational therapy did not exist when the current buildings were constructed. All of these programs are required to be offered if there are students who qualify

Privacy is also an issue. Schools operate under Health Insurance Portability and Accountability Act (HIPPA) and Family Educational Rights and Privacy Act (FERPA) guidelines, which require more space and privacy, because schools are being required to provide more and more medical services.

Mann said that the expectations of parents have changed over the last 20 to 25 years. He said that families have

gotten smaller and that expectations for personal space and individual attention have increased.

The emphasis in education has greatof the past 50 years, according to Steve ly changed in the last 20 years, as well, according to Mann. The focus now is Mann said the proposed projects are on the academic growth of an individual student and not the collective. "This has triggered a fundamental shift in how instruction, especially at the grade school level, is delivered," said Mann.

He also said that enrollment in the district has remained relatively steady. From 1982 to 1992, the average U.S.D.

211 enrollment was 761 students. The average full-time enrollment in the 20 years since 1992 is 716, which according to Mann, is closer to a head count of 730, based on how the state counts kindergarteners.

The last bond issue election in Norton, U.S.D. 211, was May 1974 for the construction of the current high school which required 12 mills and a 15-year re-payment schedule.

By State law, property tax is the only way schools can raise funds.

All residents of U.S.D. 211 who are of legal voting age and who are registered to vote by March 11, 2014 will be able to vote on the bond issue. This includes the residents of Clayton, Edmond, Lenora, Norton, New Almelo and those who live in the rural areas outside of those communities. The election is scheduled for April 1, 2014 at the Norton County Courthouse.

Logan man dies in house fire

A Logan man died in a residential fire early Saturday morning. The Logan Fire Department responded to a call of a structure fire at a residence at 305 West North Street in Logan.
