PUBLIC HEARING NOTICE

The City of Norton will hold a public hearing on Wednesday, May 14, 2014, at 5:45 p.m. at the Norton City Office, 301 E. Washington, Norton, Kansas, for the purpose of considering an application to be submitted to the Kansas Department of Commerce for Small Cities Community Development Bock Grant funds under the Downtown Commercial Rehabilitation category. A specific project application to be discussed is rehabilitation of a building located at 108 E. Washington Street, Norton, Kansas that will consist of renovations including but not limited to exterior building stabilization, abatement of asbestos hazards, lead based paint hazard and the correction of code violations. The proposed scope of work includes the repointing of mortar of the face brick along selective areas along perimeter of building. Openings that are currently in filled with face brick shall be removed and insulated windows installed. Damaged and broken window/doors will be replaced with energy efficient ones. Uninsulated wood panel coverings will be replaced over abandoned windows with energy efficient windows. Exterior building lighting is included. The existing roofing system will be removed to include parapet to expose substrate and replace as necessary. A new single ply roofing membrane will be installed over 3" rigid insulation. Loose/damaged coping cap at parapet will be removed and repaired and new gutter and downspouts are included. The project will have add-alternates to address HVAC (Heating, Ventilation and Air Conditioning), Electrical upgrades and Plumbing upgrades. The estimated total project cost is \$333,335 with the grand request for \$250,000 of the project costs. Other project proposals introduced at the hearing will be considered. Oral and written comments will be recorded and become a part of Norton's CDBG Citizen Participation Plan. Reasonable accommodations will be made available to persons with disabilities. Requests should be submitted to the City Clerk of Norton by Tuesday, May 13, 2014.
