Jung for \$10.95 for 25 plants. I do know this much about strawberries. Growing them with success demands that you understand their life cycle. There are numerous types of strawberries, and it is important to know the problems that can crop up with the variety you choose to plant.

I guess I'll still go down to the store and buy a box of pretty good tasting strawberries that were grown in some far off state or country, knowing they would be a whole lot better if I only had some farm separated cream to pour on them.
