**NOTICE OF HEARING ON APPLICATION FOR VARIANCE TO THE ZONING LAWS OF THE CITY OF NORTON, KANSAS** (1T)

Please take notice that an application has been made to the Board of Zoning Appeals for the City of Norton, Kansas requesting a lot coverage variance as to the zoning laws as to certain property within the City of Norton, Kansas.

That application has been made by property owner, Donald B. Jones and Jenda K. Jones, for a lot coverage variance. The City Code, under 16-304, currently allows that the principal building and accessory buildings in a Residence District shall not cover more than 35% of the lot area. The applicants are requesting that a variance be allowed to give them a lot coverage allowance of 42.9%, in order to allow the building of a garage of up to 24' by 24' in the rear yard. The lot coverage variance is requested on property located at: 708 W. Wilton Street, and more specifically described as a tract of land commencing at a point 616.68 feet West of the Southwest corner of Block One (1), Betterton's Second Addition to Norton, Kansas, on the north line of Waverly Street, produced West, thence North 275 feet to the place of beginning; thence North 75 feet, thence West 73.33 feet, thence South 75 feet, thence East 73.33 feet to the place of beginning, being a part of the Northwest Quarter of the Southeast Quarter (NW1/4SE1/4) of Section Thirty-four (34), Township Two (2) South, Range Twenty-three (23) West of the Sixth Principal Meridian, Norton County, Kansas.

That a public hearing will be held before the Board of Zoning Appeals as to the proposed change on the 30th day of June, 2014 at 5:30 p.m. in the Meeting Room of City Hall at 301 E. Washington, Norton, Kansas. That the meeting is open to the public and opportunity will be given for all interested parties to be heard.

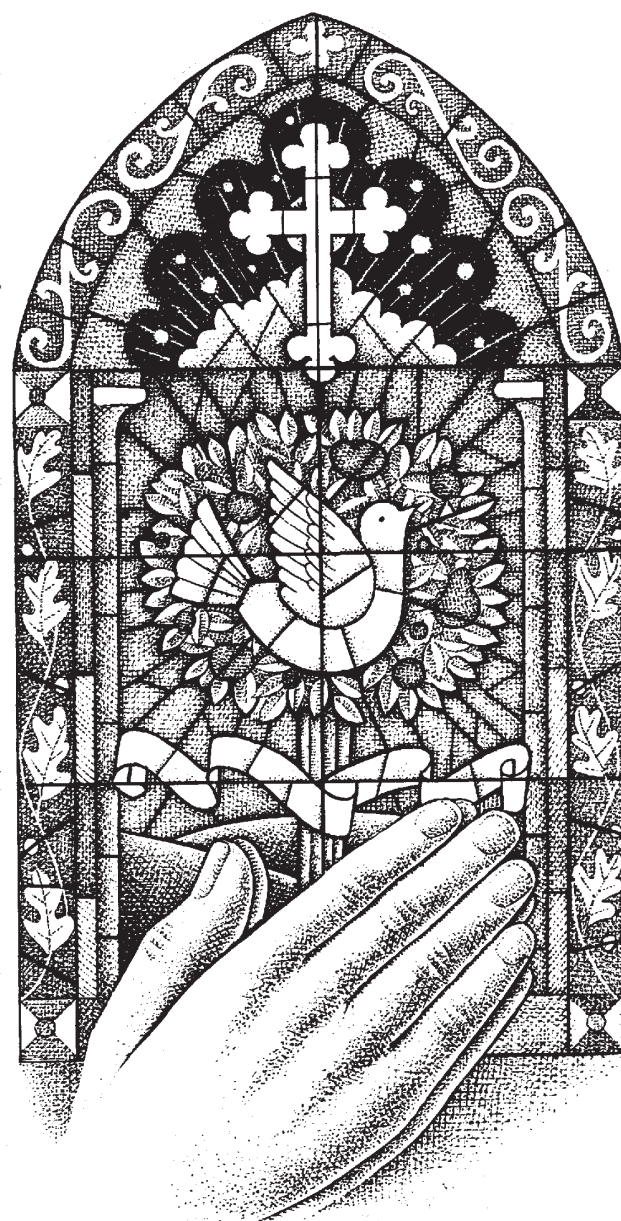
