Property taxes discussed

dpaxton@nwkansas.com The county commissioners were visited by Sleep Inn Suites representatives, Mark Griffin, Norman Nelson and Alan Hale to discuss property taxes of the hotel.

Mr. Hale started off by reminding the commissioners about the Neighborhood Revitalization Program that Norton County takes part in. This program is to encourage the improvement of blighted areas in communities and in turn they would qualify for a rebate back on a portion of taxes on new construction. In 2007 the program was set up it put a cap on the limit a business would be taxed based on income. The cap for residential improvements was \$50,000 and \$250,000 for agricultural improvements. This cap would be reduced 10 percent every ten years. At the time Dairy Queen, Sleep Inn and the Christmas distribution store all qualified for the program.

Since starting the program for these businesses they have exceeded the \$250,000 cap and in 2012 when it was reviewed the caps were raised to \$150,00 for residential and the cap on the agricultural and commercial businesses were removed with no limit to qualify. The problem is that the three businesses were stuck with the cap still pertaining to them. The men were there to say that Sleep Inn is limited and only getting a rebate on \$250,000 and since the limit was done away with could the Sleep Inn and other business have the limit raised for get a better rate on the rebate. Griffin asked, "Can we take the cap off from here on out since the hotel is doing what we wanted it to do?" Nelson spoke up to say, "The hotel is not going broke but the taxes are killing us,"

Commissioner Posson said, "If we give it to one we will have to give it to all three. We will need to crunch the numbers and look at the tax base before giving you a decision."

Nelson said that they would appreciate any help the commissioners could give them in this matter and thanked them for their time.
