# Cable prices go up \$1; channels get switched

Cable television viewers in Norton are going to have to pay a little more and will

see some changes in their channel lineup. Nex-Tech, the company that provides the cable television for Norton, is raising rates and making some changes in programming

Because of rising expenses for programming, the cable provider is raising the basic package rate by \$1, said Cable Television Operations Manager Ken Kendall.

The cost of the basic package will be \$27.45, while the basic bundled rate will be \$20.45. The cost of the expanded basic package and all other packages will not change.

He said the 5 percent increase is less than the 9.6 percent increase that Nex-Tech has experienced in programming costs from June of 2002 to June of 2003. The price change will go into effect on Feb. 1

Mr. Kendall said the company has only raised rates once since it came to Norton.

Nex-Tech is also switching the ABC and WB stations out of Denver with those out of Wichita, he said. No longer will ABC and WB be in the expanded basic package. Now, they will be part of the regular basic package. The other change with the two stations will be the one-hour time difference.

"The reason why we're doing this is assaults me with its worst, the best is yet because the customers told us that they wanted more Kansas stations and family programming," Mr. Kendall said. "So we went to the effort of picking it up for today.

them.' They will also be adding C-SPAN and The Food Network to the basic extended package. He said Nex-Tech was adding these channels because customers re-

quested them. These two channels are in addition to NBC out of Great Bend and Fox out of Wichita, which were added earlier this year.

The channels will be added on Dec. 22. Mr. Kendall said the reason the expanded basic rate wasn't going up in price, even though two more channels were being added, was because Nex-Tech dropped the two Denver channels.

The new channels will be: ABC - 10; WB—33; C-SPAN—40; and The Food Network — 46. NBC is on channel 2 and Fox is on channel 24.

## Change in bond payout causes airport headaches

Finances have been a major concern for the Norton Airport Board this year.

Board President Ivan Kingham said the airport has just enough money to make it to the end of the year, and then should get more at the end of January.

The airport has had to go to both the city and the county to ask for extra money for this month and November. And, Mr. Kingham said, it expects to be \$800 in the hole in January as well because of a miscalculation on bond payments.

When the airport redid the runway this year, the board thought they were getting 30-year bonds, which would have kept the monthly payments low enough that they wouldn't have a cash

shortage. But a 30-year bond couldn't be done for the loan they received, only a 20-year bond, which made the payments higher putting the airport in debt.

Mr. Kingham said in the end, they'll be saving money with the 20-year bond, but it makes it a little more difficult when payment time comes.

He said the board hasn't gotten a budget increase from the county or city for about eight years, but that the city will be giving them a budget increase in 2004.

"We did approach the city and county some time ago to tell them we were going to be out of money in 2003," Mr. Kingham said. "But they were both facing budget cuts from the state and (Continued on Page 5)





The previous Saturday they got the 2003-2004 season off to a roaring start when 275 pounder Michael Sprigg pinned his opponent to earn the Blue Jays a team championship in the Hoxie Invitational by  $1 \frac{1}{2}$  points over the defending state champion Indians.

This victory was not as dramatic since team scores were not posted from match to match in the finals. Norton did not know that they had scored 147 1/2 points and Junction City's total was 147 until after the tournament was over. And, although Sprigg wrestled and did win the 275 pound championship, his title match was not the final match of the day for Norton. Due to a snow storm, teams from Abilene, Basehor-Linwood and Ellsworth did not compete and some weights were so small in numbers that round robin competition was held. Sprigg's weight was one of these and he had only one other wrestler in his class. He wrestled Thomas Carter from Junction City twice, pinning him with 2:23 elapsed in the first match and making him count the lights with 2:45 gone in the second match. Needless to say, Sprigg finished ahead of the other Norton wrestlers.

The final winning points were scored by Norton's 215 pound wrestler Sean Lauer. He had two other wrestlers in his weight class. Lauer defeated Skyler Stevens, Clay Center, 8-4 in the first match. In round two, he received a bye, then pinned Jamal Wilcox, Junction City, in 3:48 to win the championship and earn enough points for Norton's team championship.

Placing third as a team was Salina South with 111 1/2 points, followed by Beloit, 108 1/2:

medals. Nathan Broeckelman (119) and Scott Goldsby (145) finished second and Lance Roe(135) finished third. Logan Keiswetter (103), Curtis Black (140) and Jordon Haussermann (152) all finished fourth.

"Because we were hit by the flu bug during the week, we opted to wrestle with a smaller squad in hopes of getting well for the next week," said Coach Johnson. Several of our wrestlers who had been fighting off sickness did wrestle and it showed in the third period. You can't substitute in wrestling. Either you're 3:01 on the mat or you're not. There's at least three matches where we got pinned.

'We didn't wrestle very well but will have to build up our strength for this weekend because we will really be challenged."

(Continued from Page 1) couldn't do anything about it." Another thing on the city and county's minds is the airport's upcoming apron project.

Mr. Kingham said the project of replacing the airport's old asphalt apron with a new concrete one will cost around \$250,000. It has to be done though, because the apron the airport has now is falling apart.

Both the city and county have set aside money to pay for this, he said, and they won't be paying the entire \$250,000, just 10 percent of it. The state will be paying for the rest, because the airport qualified for a 90-10 match.

The state will pay for 90 percent of the project and the city and county will pay the other 10 percent, plus the cost of engi-

#### neering. He said both the county and city have set aside \$15,000 in their 2004 budgets to pay for

Mr. Kingham said the board is in the process of selecting an engineering firm to draw up the plans for the new apron. They have received two bids - one for \$6,000 from BG Consultants and another for \$11,000 from Kirk & Michael of Lincoln. Kirk & Michael were the engineering firm which did the work on the runway project.

He said he hoped the apron project goes through without a lot of problems, because it will cost a lot more to do it in the future without the state's help.

Once the apron project is finished, he said, there shouldn't be any more major repairs at the airport for a while.
