Briefly Slow down

for construction

Motorists traveling between Hill City and Norton will find reduced speed limits due to road construction on U.S. Highway 283 and K-9.

On the 18-mile section of US 283 north of Hill City to the K-9 junction, the speed limit is 60 miles per hour. The two-mile shoo-fly detour shared by the highways has a work zone speed limit of 40 miles per hour. Work will continue through the

winter months in an effort to complete as much construction as possible without disrupting traffic. When spring arrives, U.S. 283 will be closed from Hill City to the junction with K-9. The two mile U.S. 283/K-9 section will remain open throughout the project.

The Kansas Department of Transportation and Kansas Highway Patrol remind drivers to be alert for construction activity adjacent to these roads and remember that fines for speeding are doubled in work zones.

City sales tax revenue not keeping up

In late November the state sent the city \$12,625 for sales taxes paid in October. This is down from the \$13,3938 received last year and is the lowest amount received in October in the seven-year period. The highest amount was \$23,223 in 2000 and the next lowest was what was received last year.

The total sales taxes received by the city for the year as of Oct. 31 is \$167,129, also the least that it has had in the seven year accounting period. The highest received from the state was in 2001 when the city the finance committee had met with the
