### Indians place in top three

Eleven track squads were on hand April 28 to compete at the St. Francis High School Invitational track meet.

The weather was cooler than some years and the Kansas wind was blowing but the athletes put forth good efforts.

The final results showed Decatur County/Oberlin winning the boys division with a score of 117 points. Burlington came in second with 99 points and St. Francis accumulated 97 points for third, making it a close race between second and third.

Five first-place finishes earned the Indians 50 points out of their total of 97. Trent Kinen earned two first places by winning the 110-meter and 300-meter hurdles, while Matt Raile placed first in the triple jump and Trent Raile won the long jump. The final first place event went to the 4x100-meter relay team comprised of T. Raile, M. Raile, Kinen and Drew Zwegardt.

Three tracksters and the 4x400-meter relay team won second place: T. Raile won the 400-meter dash, M. Raile the 100-meter dash, and Sam Sowers the 110-meter hurdles. Relay team members were M. Raile, Kinen, T. Raile and Zwegardt. Eight points are given for a second place finish, giving the Indians another 32 points.

The Lady Indians collected 53 points for fifth place. Tribune - Greeley County came in first with 107 points, followed by Oakley with 83 and Weskan with 64.

Placing second were Sidnee Crabtree in the shot put and discus and Elizabeth Gienger in the 400-meter dash.
