### Companies offer helpto low-income families in county

Priority Oil and Gas and Energy Outreach Colorado are reaching out to help Cheyenne County residents subsidize their winter utility bills from Nov. 1 through April 30.

Gas president and owner, realizes the rising energy costs have created difficulties for some families to meet their winter heating costs. Assistance with part of their energy bill is now available for qualified applicants.

To qualify, a person' combined income (before deductions) of all people living at the address may not exceed the guidelines on the chart below. An adult living at the address must be personally responsible for purchasing heating costs incurred at the residence (payable either to the landlord or to the fuel vendor).

The resident must also be a permanent and legal resident of the United States and Cheyenne County.

### Coyote hunters represent 11 states including Kansas

The 2007 Midwest Coyote Calling Contest was held over the weekend and brought in many hunters, camera crews and sponsors as well as people coming just to see the action.

From Friday through Sunday, the hunters traveled from 11 states including Kansas. Participants reported 715 coyotes spotted which is around 200 more than last year. There were 210 brought back to St. Francis.

There were 65 Predator Xtreme teams and 50 Sportsman teams which totaled 115.

Brent Rueb has organized this event for 10 years.

"Everything went very smooth again this year," Mr. Rueb said, "and we had an excellent turnout."

Over \$30,000 in money and prizes were given out.
