Board agrees to pursue new gym

The new gym project was on the St. Francis Board of Education agenda when they met on Feb. 12. The board agreed to continue looking into the costs and more will be known at the March meeting.

Carl Werner, superintendent, said that the board could reasonably finance a \$1.5 million project from the current and future Capital Outlay funds. Rather than take the entire

the fund and the \$500,000 would come from bonding against future Capital Outlay funds.

Each year, 4 mills are collected just for Capital Outlay. From this fund, school buses and equipment are purchased and major present gym used for B-team games. A bigbuilding improvements are made. Teacher's salaries cannot be taken out of the fund. In the next five years, Mr. Werner estimates
