## Construction of Bird City dairy begins

Dirt work has begun to build the Bird City Dairy. A bulldozer has been a curious site along highway 36 near County Road 32 east of Bird City for the last couple of weeks. Now the dozer has been joined by many large earth moving machines from Sporer Land Development in Oakley.

Last week a producer meeting was held to fill the feed needs of the dairy. Mike McCarty was on hand to meet with approximately 65 of the area's producers. He answered questions for the group as well as

Needs include corn silage, alfalfa hay in dairy quality as well as dry cow quality, wheat straw, and dry corn. Quality requirements and delivery and term contracts were discussed. They will also consider wheatlage, triticale, and sorghum silage as other possible forage options.

A September 1 beginning milking date is still planned.

"Housing for dairy employees is still needed." Bird City Century II Director Cathy Domsch said.

# **Board gives fair book printing to member**

There were two bids for the fair book at the Cheyenne County Fair Board meeting on Thursday night. After hearing the bids, the board voted to give the bid to one of the board members.

Casey McCormick, ad manager for The Saint Francis Herald which has taken care of the fair book printing for the last two years, presented his bid. Mr. McCormick said that printing costs have gone from \$758 to \$838 in the last two years, however, he had sold more advertising for the book last year. The board receives 15 percent on all ads sold. The total cost for the book in 2005 was \$468, and in 2006 it cost \$375. The books prior to that were being printed through K-State and the cost was approximately \$1,500.
