Due to the interest expressed by

community members, the Idalia Sanitation District will have director representatives available to answer questions after the forum. There are three ballot issues which the District has added to the November ballot for voter approval.

Ballot Issue 5A asks for approval of the voters for a 3 mill increase for a total of three mills to allow the district to collect a total of \$1318.00 per year. This will be budgeted for the increase in expenses to the Idalia Sanitation District's budget which has occurred due to the reconstruction of the district sewer lagoon.

Ballot Issue 5B is an initiative to allow the Idalia Sanitation District to collect, retain, and spend all the revenue generated as needed, which is currently restricted by C.R.S. 29-1-301 (Tabor Amendment) of the Colorado State Statutes. The relative volume of the District's budget is small and is felt over-complicated by the costly additional accounting measures mandated by the State

Statute restrictions.

Ballot issue 5-1 asks for approval of the voters to eliminate term limits for Directors of the Idalia Sanitation District. The number of people interested and available to fill these volunteer positions is very limited.

Facets By Barbara Delinsky

FACETS was Facets from the opening shot, a natural when the book was first published in 1990 and a natural today. This is a many sided book in several regards. Think of a gem. On one side, there is Hillary Cox, a writer; on another, Pamela St. George, a jewelry designer. On a third, there is Pamela's brother John, a mining magnate; and on a fourth, Cutter Reid, once a devil-maycare tourmaline miner, now as sophisticated as John.

In setting, Facets ranges far as well, from the glitz of New York to the elitism of Boston to the nitty-gritty of the small Maine minning town of Timiny Cove. Likewise personalities: Facets pits the arrogant, self centered John a against the newly vengeful Hillary, the creative and senitive Pamela, and the doggedly selfmade Cutter.
