County historical society plans second cemetery tour

The Cheyenne County Historical Society is hosting a tour of the cemeteries of northeast Cheyenne County on Sunday. Join the caravan of cars at 1:30 in front of the Bird City Library.

Stan and Dee Dorsch will lead the way, stopping first at Evergreen near Big Timber. The history of this congregation goes back to 1886, when a Sunday school was organized.

Later, this group formed the Evergreen Church. It became the hub of much activity for early settlers north of Bird City. The cemetery is all that remains. To visitors it is a silent reminder of those who lived and worked in this once thriving community.

Family members of Lucius and

Nancy Hill Heaton, who homesteaded in the area, are buried in this well-manicured cemetery. Some of the names found on other early markers are: L. R. Heaton, E.M. Philips, Jere Miller, Joseph Miller, A. Damar Smith, and W. H. Nelson.

In this cemetery, a fence once surrounded the Philips' family plot. The fence is no longer there, leaving these burials unmarked.

Another stop on the tour will be the Bird City Cemetery. This cemetery was established in 1887 when the city purchased six acres of land from Joseph and Polly Miller for \$150.

In May 1915, it was reported that every grave in this cemetery

had been marked. However at this time, there are several unmarked early burials.

The Stephen Witham family mistakenly believed that the cemetery would be south of town, so they used that area as a burial place for their two children in 1887. That exact location has been lost.

Tour these burial places with the Historical Society and hear more interesting stories about early eastern Cheyenne County settlers. Meet in front of the Bird City Library at 1:30 on Sunday. A stop at Heritage Corner's Soda Fountain will end the day's activities.

4-H holds open house for sports shooting



New scam uses IRS for a front

Roland Roelfs, St. Francis, brought in a copy of an e-mail he had received. Supposedly from the Internal Revenue Service, it informed Mr. Roelfs that he was eligible to receive a tax refund of \$268.32.

He was supposed to submit the tax refund request and allow three to four business days to have it processed. The e-mail went on to say that the refund could be delayed for a variety of reasons, for instance, submitting invalid records or applying after the deadline.

This e-mail came to the wrong person as Mr. Roelfs is experienced in knowing about the Internal Revenue Service

as he has, for a number of years, figured taxes for senior citizens.

"For one thing, the IRS never deals with pennies (such as the 32 cents he was supposed to have in the refund)," he said. "They either round up or down to the dollar."

Mr. Roelfs said that the Internal Revenue Service does not contact people by e-mail.

Mr. Roelfs has contacted the law officials about the scam.

He also warns people to beware that they may, unknowingly, submit valuable information such as the tax return which gives the person's address and Social Security number which could lead to having the person's bank account cleaned out.


