

Bid for front steps comes in too high

The front steps at the courthouse have been closed since December when they were deemed "unsafe." The county had received a grant for \$78,384 from the Kansas State Historical Society to restore the steps to their original state of limestone. The county's cost would be around \$20,000.



However, when the bid was opened at the Oct. 16 Cheyenne County Commissioners' meeting, it was too high.

Eric Johnson and Darrin Saenger, representing Campbell and Johnson, an engineering company out of Concordia, were at the meeting. The company had been hired to oversee the steps job and they were there to discuss the process of the bid before it was opened at 1 p.m.

The only bid was from Mid-Continental Restoration Company, Fort

Scott. It was for \$133,900 which was \$35,920 over the total project budget of \$97,980.

The commissioners agreed that the project would need to be bid again. Mr. Johnson said he would contact the State Historical Society on how to proceed with the project.

Winter is setting in so it will probably be next spring before any work will start on the new steps.

Swede and Elberta Calnon

Couple celebrates 65th anniversary

Swede and Elberta Calnon, St. Francis, will celebrate their 65th anniversary on Wednesday, Oct. 31.

It was a sunny fall day on Oct. 31, 1942. Swede was dressed in a double-breasted blue suit and Elberta had a lovely long white dress with a long train. She said that the dress had come from Denver and cost \$15.

They were married at the Evergreen Church between McDonald and Bird City with their friends, Mildred Hubbard and Gordon Latta standing up with them. Following the ceremony, they met with friends and family at the Albert Wilkens home (Elberta's parent's home) where they enjoyed roast beef and a cake baked by Elberta's mother.

Growing up, Swede and Elberta went to country school, Swede's school was 7 miles south; Elberta's,

7 miles north. However, they both went to high school in McDonald. Elberta said she had her eye on Swede for a long time. Swede said he also thought she was pretty sweet but his friend liked her and she didn't treat him very nice.

"I didn't want to be treated like that," Swede said.

"And I didn't like your friend," Elberta said.

They eventually got together, went to the prom and had a good time.

Both were only 19 years old when they started their life together. Mr. Calnon was working on a ranch for \$1 a day. It wasn't much money, he said, but a pair of overalls or a pair of shoes cost about 98 cents.

They described their first home as a "shack." They carried water and burned corn cobs.

The Japanese had bombed Pearl Harbor and war had been declared. In 1944, Mr. Calnon was drafted into the Navy.

"I was a farm boy — I had never ridden a train or seen the ocean," he said.

But, basic training in Farrgut, Idaho, helped the farm boy to grow up in a hurry. Because he was tall (6-foot), he was one of four (also tall sailors) responsible for raising and lowering the flag each day.

"We were lucky — no mess hall duty but we had to look sharp with shoes shining and be on time," he said.

He was transferred to Seattle, Wash., and Mrs. Calnon joined him for two weeks. He was gone all day. Bored and short of cash, Mrs. Calnon got a job.

"I came home and Elberta said she had a job waiting tables," Mr. Calnon said.

"The tips were good," Mrs. Calnon added.

Mr. Calnon was at the Battle of Iwo Jima as well as stationed on a ship ATA 177 in Japan, South Korea, Saipan, Tainan, Guam and Philippine Islands.

"I wrote him every day while he was gone," Mrs. Calnon said.

Mr. Calnon said his letters were censored so, occasionally, all Mrs. Calnon got in her letters was confetti.

Back home in Cheyenne County, Mrs. Calnon's brother-in-law, John Harper, had suffered a heart attack. He offered the couple a place to live if they drilled the wheat, harvested and shocked the feed in the field and calf out and milked six cows. There were two cream checks a week. The Calnons got one and Mr. Harper, the other. Mr. Calnon also worked for Wilbur

Curry, Deb Sherlock and Loyd and Roy Waters.

They worked hard. Swede said Elberta worked beside him in the fields and the barn. Their highlight in life was the birth of their daughter Vicki in 1952. Elberta said Vicky came easy as she had been working and milking cows up to the time of her birth.

In the 1960s, they turned to raising racing greyhounds. Mrs. Calnon said the money they got from the dogs kept them in food

Through the years, they have enjoyed friends and playing cards. Swede has served on numerous boards including being a commissioner, fair and Veteran's board member. He is just finishing up his eighth year on the hospital board. Elberta cooked at stags and the Vet's hall.

"We've had a few ups and downs but it has been a good life," they both said.

When asked if she had ever considered divorcing Swede, Elberta laughed and said, "no! but I have considered murder several times!"

They said they have been married for 65 years and still enjoy talking to each other.

"It's been a good ride!" Swede concluded.
