# **Tipsforkeepingheatingcost** down through the winter

stead. Here are some great weatherizing tips from Bird City's Clerk, Jana Diers. Ms. Diers says, "While everyone is thinking about windows and doors, there are some hidden culprits that can go unnoticed and can lead to those unwanted, unexpected expenses."

Ms. Diers said, "One of the most overlooked threat is the underground sprinklers. Checking for leaks, draining the lines and repairing them before turning them off can prevent pipes from freezing and cracking."

Another threat that can be remedied is by simply inspecting

the basement for

cracked or broken water pipes. And for homes that still have water barrels, take a few moments to see if the insulation has shifted If it has, repack with Styrofoam packing peanuts or newspapers. If the water line from the meter to the house breaks due to freezing, the tenant is responsible for repairs.

Last, but not least, are the windows and doors. The winterizing of the basics is almost a "gimme." Weather stripping around the doors and windows are a must to keep those high utility cost down, and if the budget permits, repairing of those broken and cracked windows; even the ones in the attic and basement. If the funds are just not there, Ms. Diers suggests a window covering that can be applied and shrunk to fit any window with a blow dryer. This can be bought at the local hardware store and is called "Frost King" and comes in two sizes: 42 inches by 62 inches and 62 inches by 210 inches, and pricing starts at \$3.49.

And here is another cost saving tip, some of those overhead ceiling fans can actually heat the house! If the fan has a reverse switch, turn it on, this will cause the fan to rotate clockwise and pull the heat upward towards the ceiling and distribute the heat through out the room. The bottom line is that if these few simple preventive procedures are taken, the cost of winterizing is well worth the effort considering the ever rising cost of utilities.
