The St. Francis City Council met with the Cheyenne County Commissioners Friday morning in an effort to solve communication problems between the city law officers, sheriff's officers and the 911 dispatchers. At the end of the discussion, a 911 Dispatch Committee was proposed. However, before it is official, there needs to be a resolution plus, each member of the committee must undergo and pass a FBI background check.

the building but, it had set empty for 4 years.

The building will become the home of Ross Manufacturing's main office and machine shop as well as Sunshine Travel. The machine shop has been located on West U.S. 36 but there was not enough power to run the equipment.

"I need three-phase power and the building was wired for it to run the freezers and coolers," Mr. Ross said.

"It is an old but structurally, well-made building."

There will be considerable remodeling done in and outside the building and when it is complete, there will be around 9,000 square feet. For the past

#### Organization gives money to groups

The St. Francis New Generation Fund and Community Foundation have recently made donations to four local groups: \$1,500 was distributed to the senior center, the Historical Society, the fair board,

and the Prairie Land Food. The \$1,500 represented the interest accumulated by the

endowment fund. "The bylaws dictate that none of the capital from this fund is ever spent, but the interest is donated

annually for the betterment of St. Francis," said Robert Grace, board member.

While the New Generation Fund has existed for 20 years, there is a new addition: The Community Foundation, which was created to help fund local projects by utilizing the group's federal income tax donation status as a 501(c)3, and by using board expertise to apply for grants
