Land dispute continues; council makes no decision

At the last meeting, Craig Schoenrogge, who lives south of St. Francis, had presented the city council with a proposal for settling with the city. The council asked for time to review all the easements and report back at the Tuesday, March 4, meeting.

council Rodney Bracelin, member, had worked with Mr. Schoenrogge in the past two weeks. Mr. Schoenrogge had said he didn't want the money (\$25,000), but would like to have the fence fixed and maintained around the well, the property cleaned up which included the old telephone poles taken down, wants the electrical line raised to 30-foot high, and access to water from city Well 7.

J.R. Landenberger, city manager, said, "The pumps from city wells are not always on for periods of time so he would need to have a hydrant and a holding tank installed." The council asked him to look at the cost for installing the hydrant and holding tank. Mr. Landenberger told the council that the city crew could start fixing the fence and remove old fences on the property, but raising the lines would add another cost to the

Mr. Bracelin said he would contact Mr. Schoenrogge with the information that the city will start on the two projects of fixing fence and moving poles, however the other two requests will be put on hold until they can be researched further
