Bids sought for ambulance

The Cheyenne County emergency service director reported at the Monday commissioners' meeting that she has started looking for a new ambulance.

Janelle Bowers, director, said she had talked to two companies and was looking for a dually, fourwheel drive vehicle ambulance. She was hoping the low bid would be a Ford as there is a Ford dealer in the county.

The county's ambulances had passed state inspections.

Mrs. Bowers had met with the emergency medical technicians to discuss plans for severe weather. It has been a year since a tornado hit the Bird City area.

Mrs. Bowers had asked the dispatch director what would happen if a tornado were to hit St. Francis where the center is? She was told that, whoever was on duty would stay in the center until the very last minute and would then take a handheld radio to the basement where there was cover from danger but would continue to dispatch.

Mrs. Bowers said that she plans to move the office into the new emergency building in St. Francis by April 30.

Vouchers questioned

The commissioners, before approving the bills, reviewed several of the vouchers. There were two from the appraiser's office (vouchers 16268 and 16278) concerning training in Topeka. They questioned the extra night's stay (motel cost \$73) and 8 miles driven to the training from the motel but agreed to pay. They also checked out

voucher 16264 concerning shotgun shells purchased by the sheriff's department for \$21.88.

911 dispatch

Carol Gamblin, 911 communication director, was concerned that, when all the bills had been paid for the 911 system, they had come up \$6,833 short. Money has been used from the 911 fund for several projects, all qualifying for 911 funding. That fund has been depleted until the next payment is received.

The commissioners agreed to take the money out of the capital outlay fund.

The city of St. Francis had asked the dispatch center to take over sounding the tornado siren because there the center is manned at all times. However, to take over the service, there is a need to have either a new phone line or a wireless internet line. The wireless signal would have a onetime charge, while a phone line would have a monthly charge. More information was needed before making any decisions. In the meantime, the city crew continues to blow the 7 a.m., noon and 6 p.m. whistles and can sound a tornado siren if needed.

Mr. Flemming reminded the commissioners that two of the county's tractors will be sold at a consignment sale this weekend.

Wireless company proposes new location for a tower

Chris Riha, Viaero Wireless, site acquisition manager for central Nebraska and northern Kansas, set up equipment to show the commissioners what kind of tower his company was wanting to set up near St. Francis. A Viaero representative had approached the St. Francis City Council last year proposing that a tower be set up on a lot next to a home. The council finally agreed that the site was not the right site.

This time, Viaero proposed that a tower be set up just south of the county shop. It would be outside the city limits on land belonging to Bob Ochsner, but still near enough to give good service for cell phones and internet.

The first proposal had the tower at 150 feet but, the Federal Aviation Administration said it was too high, recommending that it be no taller than 137 feet. Mr. Riha said the engineers said that even 135 feet would be sufficient so that will be the tower's height.

The tower location will be close enough to serve homes, schools, health facilities and businesses. The company plans to have towers and service along U.S.36 with each tower being 20- to 25-miles apart. There are towers at Oberlin, midway to Atwood and McDonald. Eventually, there will be towers in Kensington and Smith Center, then they will continue down U.S. 36 to north of Topeka.

Mr. Riha said Viaero is a GSM which is global system for mobile communication. A commissioner asked about Nex-Tech coverage. Mr. Riha said Nex-Tech is a CDMA (Code division multiple access) and will not be compatible. However, AT&T and T-Mobile along with some other companies with GSM will be able to use the towers, thus having better

He said the tower, which will cost \$100,000, is a self-supporting, lattice tower which will be in compliance with rules and regulations. There will be a small building, a backup generator and buried 1,000-gallon propane tank to run the generator. This will be surrounded by a padlocked chainlink fence.

The commissioners said that, if the Federal Aviation Administration sent a letter of approval and the neighbors were in favor of the tower, they would approve of the tower placement. Dave Flemming, road and bridge supervisor, also approved of the tower being beside the county shop.

Viaero, after receiving a letter of permission from the Aviation Administration, has tentative plans to have the tower erected sometime this summer.


