

The park is now on the list of the Register of Historic Kansas Places. They will be sending it on to the National Register of Historical Places.

The council decided they should be forming a committee to look at the cost and what needs to be done to restore the band shell. Several years ago, Garnet Miller left money to go to this project. There has been other money donated. The Cruisers just donated \$650 from the "Elvis" show. Also, the Association to Benefit Cheyenne County donated \$1,102 to the band shell.

Councilwoman Carla Lampe will contact Katrina Rigler, manager of the Heritage Trust Fund grant program, to see what needs to be done to apply for a grant.


