# 4-H'ers show in style revue

In all, there will be 15 construction garments and about 50 different buymanship outfits presented at the revue.

Monday evening about 6 p.m., of Drew and Stacy Kaup, 7 inches the wind started blowing in the of rain fell. Mrs. Kaup said the Hackberry area, 12-miles north of St. Francis. By the time it had moved through, it had dumped buckets of rain, ruined gardens and fields of feed, and broke off huge trees at the base.

The rain, said Merle Mills, farmer/rancher, seemed to be limited to a small area. He had received 5.65 inches on an official rain gauge.

Two miles west, Helen Brown only received around 2 inches. However, east of him at the home

### Forum held for candidates

karen.k@nwkansas.com Around 130 people attended the Cheyenne County Candidate Forum Monday evening at the high school auditorium.

"We were very pleased with the turnout," said Tom Keller, one of the members of the Community Builders, who organized the forum.

"The goal of the forum was to educate the community on the candidates and their stand on issues," said Casey McCormick, Builders selves. member. "The participation of the candidates was outstanding."

Surrounding communities have also had similar forums with less attending. Andrea Wyrick, who is running for District Judge, position 2, said it was one of the better run forums she had attended.

All but three of the candidates running for office were in attendance. Kari Gilliland, county attorney candidate; Ray Lee, com-Beikman, commissioner, District 3, were unable to attend.

However, all three candidates running for District Judge, position 2, were there. They included Kevin Berens, Scott Showalter and Andrea Wyrick.

Others present were the county treasurer candidates, Dolores Jenik and Carl Jenkins; magistrate judge, Robert Van Allen and writein candidate Steve Orth; sheriff, Craig Van Allen, incumbent; Dave Warren and Philip Wolters; and Dale Patton, Independent, running for commissioner, District 2.

They, along with Terry Miller, clerk; and Mary Morrow, register of deeds, each introduced them-

Jeff Beims was the mediator. Candidates were then asked three questions concerning the office they were running for. They were given 2 minutes to answer. Most were short, concise answers.

There was one question asked from the floor and it was addressed to the sheriff candidates. The question was if the candidate thought the present number of sheriff's officers was necessary? All three missioner, District 2; and Andy said the number was adequate for covering the county. If anything, Sheriff Van Allen said, the area wasn't sufficiently covered at all hours and there were gaps.

Mr. Wolters said he thought the

staff was a "good adequate staff" and would not change anything.

Mr. Warren said that most people work 8-hour days. If there were only two officers and they worked 12 hour shifts, there would be problems with vacations, time off and sick days. He didn't think it would work.

Following the forum, there were refreshments and a chance for the people to visit one-on-one with the candidates.

"I think the forum was a success, especially for the first one held in St. Francis," Mr. McCormick said.

The primary election has been set for Tuesday. Many of the offices are running uncontested in this election. However, there are three seats, that of sheriff, treasurer and District Court Judge District 15, position 2, that will be decided in the Tuesday election.

Featured this week will be the candidates for sheriff and treasurer, along with a write-in candidate, Steve Orth, who is wanting to have his name listed on the ballot in the general election.

The office for sheriff has three candidates listed on the ballot and all of them are Republican. They include Craig Van Allen, incumbent; David Warren and Philip J. Wolters.

Running for county treasurer are Dolores Jenik, incumbent; and Carl Jenkins.

#### **Sheriff candidates**

Craig Van Allen has been the

Cheyenne County Sheriff for

over a year, having stepped up when Sheriff Troy Gardner resigned.

Before then, he had been at the county sheriff's office as deputy for 2 years and 1 year at the city police department. Also, for 3 years, he was a Lindsborg Reserve Police officer.

I am dedicated, he said, to protecting lives and helping people in need. He thinks it is important to conduct thorough investigations and creating a safer county for the future.

The sheriff's office oversees the county and the city of Bird City. Officers are available to help the city of St. Francis officers when called upon.

In the time he has been sheriff, he has established working relationships with other agencies.

He graduated from the Kansas Law Enforcement Training Academy and has over 100 hours additional training in Kansas Law Enforcement.

He is knowledgeable of the current laws and applications.

"I have dedicated myself to work hard and earn the trust of the people," he said. "Through this commitment, I have been able to advance from part-time deputy to the current sheriff."

Sheriff Van Allen has lived in the county for 35 years and graduated from St. Francis Community High School. He and his wife, Sharon, have two sons, Trey and Josh.

He is a member of the Lutheran Church.

Prior to working in law enforcement, he was employed as the department manager at Van Allen, Wheeler, for 20 years.

He is concerned that the tax dollars are used wisely and that all people are treated fairly. Whatever the situation, he said he has the courage to face it.

David Warren is running for sheriff of Cheyenne County on the Republican ticket.

Mr. Warren has worked for the St. Francis city police, was a senior correctional and field training officer at Kit Carson Correction Center and a member of the Kit Carson Correctional Center Special Operations Response Team.

He graduated from the Kansas Law Enforcement Training Center and is a National Rifle Association Law Enforcement handgun and shotgun instructor, as well as being a certified chemical agent and concealed carry instructor for Kansas.

In a rural farming community such as Cheyenne County, he said, law enforcement is about getting to know the people you serve and find out what their concerns are.

He sees that, with the rising costs of fuel, there will be a rise in thefts in rural areas where there are fewer chances of getting noticed. If elected, the departments patrolling will include getting out in the county and making sure resident's property is protected.

My definition of patrolling, he said, does not include running radar on country roads or harassing the farmers who are busy trying to make a living. He also plans to work closely with the other departments including the city po-
