Ray Lee

County Commissioner District 2 Ray Lee has lived in Cheyenne County almost all of his life except for a time when he was serving the

country in Korea. He said he likes Cheyenne County and that is one of the reasons he is running for a second term as commissioner of District 2. He also sees the population of the county dwindling and would like to find a way to bring people and businesses in.

"When there are less and less people, it makes it tough on the taxpayers to keep the county going," he said. "I'd like to see more businesses and jobs for young people.'

Mr. Lee was the county sheriff for 28 years and a deputy for 4 years. He worked for the St. Francis Police Department on a part-time basis for 5 years.

As a sheriff, he said he was always able to maintain his budget and have money left at the end of the year. These funds were used to help in the next year's budget.

Lee said that while sheriff, he seldom took time off and, today, if elected commissioner, will be available for meetings and to talk to the citizens if they have any concerns.

In the last 4 years as a commissioner, Mr. Lee said the board has updated some of the older equipment such as ambulances, fire trucks and other equipment. Most of it, he said, was paid for with government

He commends the emergency medical service, technicians, and the county and city fire departments, noting that they are probably some of the best in the state of Kansas. Our county, he said, also has some very good employees.

"My door is always open to anyone needing my time," he said. "I am willing and excited to hear your ideas and concerns for our district.

County Commissioner District 2 Dale Patton is running for Cheyenne County Commissioner, Dis-

In the future, she will be working at computerizing the office. A technology fund has been started and when there is sufficient money, she will purchase a scanner. She will then be able to scan documents into the computer which will make researching records much easier and

"I plan to go back as far as possible but my goal will probably be going back 10 to 20 years — it is going to take a great deal of time," she said.

She also sees minor changes which are government mandated coming into the office but nothing that is concerning.


