Whitmore of St. Francis attended Northwest Kansas District Kansas Music Educators Association Mini Convention, which was held on Nov. 1 at Hays High School in

The convention features concerts by three groups of outstanding young musicians, the High School Honor Jazz Band, the Junior High Honor Band and the piece called "Sin Palabras." Junior High Honor Choir.

Musicians from the 22-county Northwest Kansas district submit audition tapes from which the best instrumentalists are selected for the Honor Bands. Participants of the Honor Choir are selected based on director recommendation.

The students spend several weeks prior to the convention practicing and perfecting the music that will be performed. The musicians then join together in Hays for a day of rehearsals followed by public concerts in the

Eighth grade vocalists from St. Francis who were selected for the Junior High Honor Choir were Taylor Archibald and Nariah Hamilton, both singing soprano. The 266-member choir, under the direction of Joel Johnston of Omaha, Neb., wowed the audience with several beautiful vocal arrangements.

Of the 109 junior high music students named to this year's Junior High Honor Band, Sarah Whitmore, an eighth grade student in St. Francis, was selected to play first chair flute. The Honor Band, under the direction of Johannah Cox, a music educator from Lawrence, entertained the audience with a variety of songs ranging from ballads to marches.

Mrs. Kribs said she had lived in a lot of places but several years ago, she chose Cheyenne County as the place where she wanted to live.

"I want to be a part of helping grow the economy and show people what a great place this is to raise kids and to retire," she said.

Mrs. Kribs said she will be manning the office much of the time and, since she has background in fund raising and grant writing, she will be pursuing this end of the cor-

Mr. Kribs is in marketing. He is a retired director of Locke Marketing in Denver and worked for Martin Marietta (now Lockheed Martin) where he was part of the team that took over companies (government and private) in financial trouble.

Mr. Kribs said he has been a vocal critic of the Development Corporation for the last few years because there was not the level of activity he wanted to see. When the position of director came open, the Kribs put together a proposal on how they thought the Corporation would work and the board accepted it.

We view it, he said, as a challenge as well as bringing in the extra dollars to the county. They plan to organize 10 to 20 teams of two people each. They will hold a training seminar and then turn people lose. The study, he said, will tell what the business people think about the business place, what they need and

"We would like to see more kids and people coming back to the county to live- fill empty houses and farmsteads — people who buy groceries and send their kids to school," Mr. Kribs said. He added that they will target groups of people who will retire soon and meet with them one on one.

The county offers a very cost effective place to live, he said.

They would like to see business development and acquisition — no big plant, he said, as it is hard to convince companies to move and depart from the traditional way of approaching. They plan to go to colleges and trade schools which could point young entrepreneurs to the county. They will talk to the young kids as well as trying to bring in cottage industries such as those who assemble parts.

Agri-tourism, he said, brings people and money into the county.

"We will push hard to get that done," he said. "We have a lot of stuff we are going to do and, if that doesn't work, we will try something cis to do the testing.

They talked to the commissioners about funding. Andy Beikman, chairman, said when they were doing budgets, no one had come to the commissioners asking for money for the Development Corporation.

They also talked about the county's strategic plan. Mr. Beikman said that it needed some work. Mrs. Kribs said a strategic plan is needed to be able to qualify for incentives. However, she was working toward getting the county reinstated with the state and will be working on in-
