## Postal service has some tips for you

and packages expected to be delivered this season, the U.S. Postal Service has some tips to help get

Some helpful tips are make sure packages are able to withstand processing without the contents or packaging breaking. Cushion items with bubble wrap, newspaper, or "foam peanuts" so they do not shift during transit.

Wrap each item separately when packing more than one item in the same box. Remove batteries from electronic devices and wrap separately. Close and shake box to see if items are shifting, if they are, add more cushioning.

Mark packages "Fragile" in

Always use tape designed for sealing shipping boxes. Do not use string, cellophane and masking tape to seal.
