

The kitchen is in need of some wiring improvements to comply with code deficiencies.

Although this was a different fire marshal inspector, he still noted the need to make improvements in the kitchen area. Some of the wiring needs to be done now, rather than wait for the comprehensive project to meet these codes, Les Lacy, hospital administrator, said.

He and the board discussed different options and, in the end, decided to do a little more planning before proceeding with a major project. He said that Bill Wilger, maintenance, will soon have the building in back of the hospital remodeled and have his area moved into it. That would give Mr. Lacy a better idea of the room available and other options that might work.

The new fire marshal had another

and that was the east entrance/exit. He said the ceiling height was too low. Redoing this doorway has been on the long-range planning list but, the board had delayed it because there were other issues they felt were more important.

Mr. Lacy pointed out that one option was to demolish the concrete cap over the lower step and put a metal cover on at the appropriate height. This could likely be done fairly inexpensively.

Airport closed

Mr. Lacy said Ron Louden, member of the county Airport Authority Board, had told him that, in October, there are plans for the airport to be closed for rebuilding the runway. The renovation will take about five weeks and during that time, different arrangements will be made to fly out patients for further

The board talked about bringing in helicopters. Mr. Lacy said helicopters used to land in the grass to the west of the hospital but there is supposed to be 300 feet from the nearest residence.

Helicopters still land at the airport and the ambulance meets the crew there. Patients can also be transported to the Goodland airport to meet a medical flight.

Mr. Lacy pointed out that they have had some notice so they will be able to work out whatever arrangements would be needed.

Morale issue

The matter of the morale issue with the hospital staff which was brought up in the interview for the hospital board position. Mr. Lacy agreed that at times, there may be a problem but he didn't see it as a severe problem. The board was encouraged to talk to the administrator if they hear of problems.

Numbers up

Mr. Lacy said the number of visits at the Cheyenne County Clinic in St. Francis is holding stable with 503 reported in December. In Bird City, there were 83 visits in December.

He pointed out that the number of ancillarie surgeries was increasing. There was a total of 82 in 2008 which was over the 2007 total by 26. Endoscopies had a total of 103 which was over last year by two.

The big surprise to Mr. Lacy's budget was the number of babies born last year. He had budgeted for eight births but, instead, there were 24 babies born in the hospital. Slow this year were the number

of people using the physical therapy department. He pointed out the high

degree of variability in the numbers. He noted that he is still looking for a urologist to work in the specialty

Primary Care Clinic Grant

New grant applications are out for the Primary Care Clinic Grant. The current grant was originally for \$75,000 and is being cut to \$70,900 by the Governor. Mr. Lacy said Candi Douthit, RN, had successfully written a grant that would make funding available for a farm family safety program, farm extrication program, all-terrain vehicle (ATV) safety program and to pay for the rural road safety program which she is doing with the high school.

Funding the depreciation fund was discussed. Mr. Lacy said that, historically, the hospital has needed funds in January but, not this January. He said that he would like to suggest that, for this month only,

Great Plains report

Jackie John, area director for Great Plains Health Alliance, the company which leases the hospital, had an update on what is going on within the Alliance. She said the Cheyenne County Hospital is one of four hospitals that have been with Great Plains for over 50 years. The other hospitals were Smith (County) Memorial Hospital, Smith Center; Harlan County Health Systems, Alma, Neb.; and Phillips County Hospital, Phillipsburg.




