# **Projects to improve schools discussed**

By Karen Krien karen.k@nwkansas.com Summer projects to improve the schools were discussed at the St. Francis Board of Education meeting on Thursday. These projects are taken out of the capital outlay fund which is used only for these types of projects — not on salaries and other items that come out of the general fund.

Proposed projects include the new windows on the west side of the high school, the girls' rest room in the grade school and the new grade school computer lab are already on the "go-ahead" list. Bids have been approved for the three projects and Rob Schiltz, superintendent, said the representative with Norton Glass intends to start on the project as soon as school has been dismissed.

The new windows should save the school 30 percent in heating and cooling. The grade school lab will be set up similar to that in the high school. Keeping up with the pace of technology, the computers have been set up so one-fourth of the computers will be replaced every four years, thus, not burdening the school budget with purchasing all new computers at one time.

Another proposed project is lowering the ceiling and better lighting in the halls at the high school. This will be another saving in utilities.

The bulbs for these lights, while saving money, also cost around \$50 each. However, former resident and graduate of the St. Francis school. Bill Keller with Stanton Electric, offered to sell the lights to the school for one-half price.

Once these projects are done, Mr. Schiltz said, the buildings will be in good shape.

Mr. Schiltz said the area north of the grade school playground, between Main Street and the sidewalk. has been cleared of weeds and debris. The city moved the dirt out of the area for no cost. Merlyn Yonkey worked up the soil and students raked it so it was level. Now the area is ready for planting buffalo grass and a sprinkling system.

The board talked about grade school plantings in the front and the conditions of sidewalks. No decisions were made.

The board approved the list of non-licensed personnel for next year contracts. Among those positions eliminated were the junior high girls' volleyball assistant coach, junior high track coaching aide and the high school wrestling coaching aide. Talley Morrow, who had been the high school volleyball coach aide, was appointed as the head high school volleyball coach.


