AS OF JULY 1, Kansas residents can begin ordering the "In God We Trust" license tags. They are available for passenger vehicles, motorcycles, travel trailers and trucks with a gross weight of 20,000 pounds or less. The plates will be released when a certain amount of money has been collected.

Tags can now be ordered

dents will be able to order the "In God We Trust" license plates. These plates are authorized for any Kansas resident who owns or leases passenger vehicles, motorcycles, travel trailers or trucks with a gross weight of 20,000 pounds or less.

Residents can purchase a plate for each vehicle they own.

However, the plates must be purchased (price is \$45.50) in advance and when the required amount of money, \$10,000, is raised, the plates will be released. Unlike other specialty plates, this will be only a onetime fee and will not require any certification paperwork or supporting documents.

The tags will then be sent to county treasurers' offices, and notices printed in local papers to let the purchasers know they are available to pick at their convenience.

The plate was designed by Francis Landry and John Bremenkamp, Colby. According to an article which appeared in The Hays Daily News, they hoped many would adopt to evangelize their faith in God.

Mr. Landry said he felt the need to evangelize after he attended his Cursillo weekend. He patiently waited for God to show him how to proceed.

Last year, when he and his wife, Geri, were visiting their son, Keith was quite overwhelming. We actu-

ticed many Indiana tags that said "In God We Trust."

"Oftentimes while driving, our state of mind is elsewhere," Mr. Landry said. "But you get behind someone with that license plate, and it changes your mindset. It reminds you that God is in charge. I thought, 'This is a nice message to have out there on the street.' '

Upon returning to Kansas, Landry went to the Thomas County Treasurer's office to see about getting similar tags in Kansas. That's when he discovered the process was not going to be an easy task. He was told it took legislative action to incorporate a new license

plate. Mr. Landry approached his state representative, Rep. Jim Morrison, R-Colby, who liked the idea and introduced House Bill 2704. The Landry's began lobbying legislators to pass this bill. Within three months, the bill passed both hous-

"There were only three people in both houses that actually opposed it," he said. "That's a pretty good percentage.3

Now the Landry's are on another mission -- to get the people of Kansas to adopt the image.

"We needed 500 people to say they would use this tag before the state would print it," Mr. Landry said. After word got out about this we were flooded with requests. It

Beginning July 1, Kansas resi- Landry, in Greencastle, Ind., he no- ally had to use the media to help notify the public that we had reached our goal and to wait for them to be in the County Treasurer's offices before requesting them. But there is a set up fee of \$10,000 that is required to create the plate and programming done to accommodate for the issuance of the plate.

> So, starting July 1, the public can start ordering the plate. When enough orders have been completed to reach the \$10,000, the state will start printing them and disbursing them to the Counties for issuing to the purchasers. The sooner people order them the sooner this plate will become a reality.

"From what we've read, 86 percent of people believe in God and believe we should keep the phrase 'In God we Trust' on our money exchange, and keep God in our Pledge of Allegiance," Mrs. Landry said.

Yet we sit back and let 14 percent of society dictate to us and take this message away from us who believe. I pray the whole state will adopt this message."

The couple, retired from running a restaurant business, said they have not allowed themselves to become discouraged throughout this process.

"It was a little more involved than we thought, but that just made us continue. Nothing is too easy," Francis said. "We are all called to be evangelizers, and having a license plate on one's car, is an easy way to accomplish that goal."

In the letter sent by Max Lowry, president of the Logan Community Development Foundation and mayor of Logan, and James Pipes, president of the Logan Lions Club, Ms. Manion was recognized for her volunteer hours which she put in despite holding down a full-time job as an office manager and bookkeeper for the local farm service repair shop and working on a degree in leadership at Fort Hays State University, which is 70 miles away.

Ms. Manion said, because she was not a member of the American Legion, she was not able to be considered for the award. However, she said it was still an honor to be nominated. On June 12, she completed her leadership certification.
