
At the business meeting, Bonnie reported that the December donation of \$76 had been delivered to the Prairie Developmental Center in Atwood.

Sara is a graduate of Mountain View High School and is employed by TMG Marketing in Greeley. She hopes to continue her education in the near-future.


Alex is a graduate of Resurrection Christian School in Loveland and is the administrative assistant at VFIS Insurance Agency in Windsor, Colo.
