## Scam hits the region

There seems to be "SPAMS" appearing all the time. And, like the old saying goes, if it seems too good to be true, it probably isn't legitimate.

One of the latest SPAMS is supposedly for an Internal Revenue Service refund. The subject matter on the e-mail is "IRS REFUND Notification - Please Read This."

Dolores Jenik, county treasurer, had received information from Larry Kettlewell, chief information security officer, Kansas state government, saying to not open or respond to the e-mail.

The e-mail contains the following link: <http://www.tax.state-XX.us/refunds/form>; where XX can be any two letter U.S. state abbreviation. The site is using fast flux techniques to keep the destination hidden and prevent blocking.

The site appears to be exploiting various client side vulnerabilities using the "Just Exploit" kit to push malware into client systems.

The message reads:  
"Internal Revenue Service  
United States Department of the Treasury"

After the last annual calculations of your fiscal activity, we have determined that you are eligible to receive 578.16\$ tax refund under section 501(c) (2) of the Internal Revenue Code. Please submit the Tax Refund Request Form (a series of numbers and letters) and allow us 3-9 days to process it.

Sarah Hall Ingram, Commissioner"

Ms. Ingram is the current commissioner of Tax Exempt and Government Entities at the Internal Revenue Service so this makes the e-mail more believable.

Rowland Roelfs, St. Francis, who does AARP income tax returns, said the Internal Revenue Service does not send e-mails. If someone has an e-mail from the Internal Revenue Service, do not open it.
