Kitty was born Aug. 28, 1931, in Wichita and was an only child, as was her mother, Gladys.

She grew up in Wichita, playing the accordion and modeling, eventually being named "Miss Safeway" at age 5. In fact, as a child, Kitty so resembled Shirley Temple that she once wrote to the actress, including a picture, to which the actress replied, astonished at the resemblance.

She attended East High School, graduating in 1949, and worked across the street in her father's business, the "Whitehead Bakery." She attended the University of Kansas, majoring in home economics and earning a bachelor of science degree in education in 1956 and a master's degree in fine arts in 1958.

Although she was involved with and served as an officer in a number of local organizations, nothing gave her more satisfaction than being a Girl Scout Leader. While she was tough on the girls and wouldn't tolerate any fear of spiders or snakes, there wasn't anything she wouldn't do for them. She taught them to cook and camp with the best of them. She also took them on field trips to Denver, as well as hosted parties for them at the house.

Kitty adored the people of St. Francis and that feeling was only surpassed by her love for and admiration of her mother-in-law, Ruby Kite. In Ruby's later years, Kitty delivered meals to her, maintained the garden next to her apartment and took her for rides in the car, often times stopping for an ice cream cone on the way back.

Subsequently, Kitty trained under and became employed by Josephine Jaqua Churchill in the R.M. Jaqua Abstract Co. from 1967 through 1969. While in St. Francis, she was a member of the United Methodist Church.

She and her husband, John, were divorced in 1969. Thereafter, Kitty moved to Lawrence and became employed with the Douglas County Abstract and Title Co. as an abstractor from 1970 through 1977. From 1978 Kitty was married on Dec. through 1979, she was employed 17, 1950, in Lawrence to John by the University of Kansas at

Subsequently, she moved back to Wichita to help take care of in 1958 where she worked in her her parents. Kitty served as a volunteer at the Wichita Art Museum, Riverside Hospital, First Presbyterian Church and Wesley Medical Center where she worked more hours than any other volunteer - 16,000 hours in both 2006 and 2007. While Kitty enjoyed her service as a volunteer, it was the people she loved, both the ones she served and the ones she worked with.

She was a member of the First Presbyterian Church of Wichita. Perhaps the words of her niece, Lisa Warren, capture it best: "She was a trendsetter. She was adorable. She will be missed."

1/2 teaspoon lemon juice

1/2 cup sugar

2 cups cream (or half 'n' half) 2 cups whipping cream



Dave served America as an enlisted member of the Oregon National Guard (1947-50); a non-commissioned officer in the United States Air Force (1950-54); and as intelligence officer in the United States Navy Reserve (1960-78).

не attended Oregon State Uni-Oregon, graduating in 1957. He graduated from the University of Oregon School of Law in 1959. Following his admission to the Oregon State Bar in 1957, he engaged in a distinguished law practice for 51 years. He was a founding member of Hershner Hunter,

LLP, of Eugene. As he practiced law, Dave also served: the University of Oregon as an adjunct professor in both the University of Oregon Business School and School of Law and as a member, Board of Trustees, University of Oregon Foundation (1983-93.); and, the legal profession as a director of the Oregon State Bar: as a member of various executive committees of the Oregon State Bar and as a frequent contributor to continuing education programs. Member, Board of Trustees, University of Oregon Foundation (1983-93).

For his skill and willingness to give of himself, Dave was continuously recognized as one of Oregon's pre-eminent lawyers.

He was: A Fellow of the American College of Trust and Estate Counsel (State Chair, Oregon, 1990-95); A Fellow, American Bar Foundation. recognized in The Best Lawyers in America (Trusts and Estates); and recognized as one of Oregon's Super Lawyers.

Dave served the community as an active member of the First Congregational Church. He was a member of Active 20-30 Club. In 1969 - 1970, he was the president of Active 20-30 International. Dave also was very involved in state and local politics for many

Dave loved practicing law. But, he was also an avid sailor and a lifetime member of the Eugene Yacht Club, serving as its Commodore in 1984. He read voraciously and loved music.

While serving in the Air Force, Dave and Bev lived in France and explored Europe whenever possible. They returned many times.

Edna was the business manager of Zimbelman Motor until 1984. She prided herself on her excellent bookkeeping skills and being on the "Honor Roll" with Chevrolet ev-

Edna and Robert enjoyed many trips, including Sweden, Norway, Hawaii, Tahiti and Aruba.

After retirement, she enjoyed their trips to Arizona, where she made many new friends. She enjoyed her needlework, making the St. Francis United Methodist several quilts and other items, and cooking for everyone at the Hospital. park where they stayed.

Edna was a leader, 4-H, Women's Society of Christian Service at the Evangelical United Brethren Church and then United Methodist Women where she was district treasurer. She also sang in the choir.

She played golf and loved competing in the tournaments at Riverside and neighboring towns. One of her crowning achievements was organizing and cooking for the monthly stags at Riverside for almost 10 years and with volunteer help, she raised a lot of money for the Riverside Ladies to do all kinds of improvements at the club.

Her garden was her pride and joy. She planted one every year up until 2008, when canning and freezing became a little hard for her. Edna loved her children, grandchildren and great-grandchildren, her beloved companion dog, Ed, her friends and family, her church, music, cooking for the hunters, cooking at harvest and doing her needlework.
