Principal informs board about school enrollment

With start of school less than two weeks away, the St. Francis Board of Education, at the Aug. 12 meeting, discussed the endof-the-summer building renovation projects, the hiring of winter sports coaches and bus routes.

School enrollment had been held the two days before the meeting and Scott Carmichael, principal, said there had been more students enrolling than they had expected but it was too early to tally the numbers. There were also students living in rural areas of the school district which the superintendent had not expected and this meant bus routes would probably need to be changed.

The board agreed at a previous meeting to drop one of the bus routes, making four routes with Melvin Confer, Ben Leibbrandt, Ralph Lebow and Edie Walters as the principal drivers. While drivers may have to do some backtracking to get all the riders on the bus and to school, Rob Schiltz, superintendent, said he thought it could be done.

Last year, the board had adopted all-day kindergarten eliminating the noon kindergarten bus. They had also combined girls and boys on one bus to sporting events. The savings, Mr. Schiltz said, had helped with the overall expenses.

They discussed that there were several out-of-district students meeting the buses. Mr. Schiltz said it is state law that buses canunless the superintendent signs a

Coaching positions

There were three coaching positions that needed to be filled. A great deal of discussion was held concerning having head coaches be working in the school and the benefits it had in recruiting students to the different sports as well as being aware of any problems.

Larry Flemming had resigned as the girls' basketball coach. Susan Dinkel was approved to take Mr. Flemming's place. David Morrow will be the assistant high school girls' basketball coach.

has served as the assistant wrestling coach for several years, will continue in that position.

Summer projects

Mr. Schiltz reported on various summer projects including the remodeling of the biology room, new computers in the business room and the refurbishing and painting of the junior high lockers. The projects are expected to be done by the time school starts. Mr. Schiltz also pointed out that the large windows in front had been installed and, while they cost a little more than expected because of unexpected problems, they were done and looked good.

The board also commented favorably on the stand of buffalo sod on the grade school playground and the trees which had been planted on the north side of the grounds.

Budget hearing

Mr. Schiltz briefly reviewed the 2011 budget. There was no audience for the budget hearing so it was adopted as published in the July 29 issue of *The Saint Francis Herald.* Last year, the taxes levied were \$1,203,376; this year, the taxes levied are \$1,011,569.

Secretary replacement

Sharon Olofson, the superintendent's secretary, plans to retire Jan. 1, 2012. Because of the many duties included in the job, the superintendent said he would have a job description ready for the board to review at a future meeting. Then they would advertise.



Mrs. Keller's sons, John and Stanley, were on hand and when asked if they remembered anything they would like to tell about her, Mrs. Keller warned them to be careful what they said! However, that didn't stop Stanley as he told about his mother driving the old pickup to her garden. Through the years, the pickup began to wear out and eventually, the only gear it would run in was reverse. So every day, she would back the pickup to the garden, pick the potato bugs off and load the potatoes, then back the truck to the house to unload.

She was totally silent when he reminded her about the time she was doing the wash in the basement and the door slammed shut, locking her in the basement for the day.

Through the whole party, she was a delightful resident as she told about her life.

Mrs. Keller was born on Aug. 1, 1916, in Philips County out on the farm. She was the daughter of Arthur and Bertha Moody. She had a brother, Arthur, Junior, and Verla.

After they were married, Vera helped on the farm. She and Albert had five children: John, Don, Dorothy, Phyllis and Stanley.

Grandson Clay told about Grandma's jelly. He loved her jelly and, he added, it seemed like Grandpa was always finding choke cherries, wild plums and other fruits to keep her jelly jars full. This spurred on the rest of the family present as they told about her angel food cakes which were made from all the egg whites after making many noodles; butchering the chickens and making millions of apple and lemon pies.
