City utility rate increase discussed

Proposed utility rate increases for 2011 were discussed at the Sept. 27 city council meeting. J.R. Landenberger, councilman, introduced the new rates, which are an overall increase of 2.99 percent. This increase amount was agreed upon at the August city council meeting.

Sewer and trash show a fixed monthly increase; sewer increasing 80 cents and trash increasing 50 cents. Water will increase two ways; monthly meter rates will go up \$1, while usage goes up 10 cents/1000 gallons. Electricity meters are slated to increase \$1.75. These rates only apply to homes inside city limits.

Scott Schultz, councilman, stated that they have always tried to keep rates as low as possible, but that rates will have to go up in order to keep up with expenses and increases in costs. Council figured the average home can expect increases to total around \$60 per year. It was also noted by council that St. Francis rates have always been, and continue to be, lower than other towns.

An ordinance will be drawn up and passed at the next meeting, and rates will go into effect after the first of the year.
